Public Notice:

Proposed Changes to Clark County Code RE: Title 13, Chapter 13.04

The Clark County Board of Commissioners is proposing amendments to Clark County Code to amend Title 13, Chapter 13.04, by adding Section 13.04.275 which will be designated as Chapter 42 of the 2024 International Fire Code.

The proposed amendments address the following specific areas:

Section 13.04.275:

- 1) Chapter 42 of the IFC is related to the design, operation, maintenance, and commissioning of single-lane tunnel systems.

Prior to adoption of the proposed amendments, the Clark County Board of County Commissioners is required by NRS 237.080 to make a concerted effort to determine whether the proposed rule will impose a direct and significant economic burden upon a business or directly restrict the formation, operation or expansion of a business. Due to this, trade associations, owners and officers of businesses which are likely to be affected by this proposed rule, and any other interested persons are required to be notified and invited to submit comments, data, or arguments to the County regarding whether the proposed amendments would:

- a) Impose a direct and significant economic burden upon a business; or
- b) Directly restrict the formation, operation or expansion of a business.
