NOTIFICATION OF PROPOSED AMENDMENTS TO CLARK COUNTY CODE TITLE 7, CHAPTER 7.220 (NEW) – HEMP RETAIL SALES AND TITLE 6, CHAPTER 6.10 – WORK IDENTIFICATION CARDS

Dear Licensee and Community Partners:

Pursuant to NRS 237.080, please be notified of proposed amendments to Clark County Code, Title 7, by adding a new Chapter 7.220 – Hemp Retail Sales and amending Title 6, Chapter 6.10 – Work Identification Cards. The amendments are available for your review online at:

www.clarkcountynv.gov/businesslicense/proposedamendments

Specifically, the proposed amendments will revise Title 7 by adding a new Chapter 7.220 to establish regulations governing the sale of hemp and hemp-derived products. The proposed amendments address the following key areas:

- **Section 7.220.010** identifies findings regarding the sale of hemp and hemp-derived products.
- **Section 7.220.220** adds new definitions applicable to hemp retail sales.
- **Section 7.220.230** requires a retail hemp store business to obtain a business license.
- **Section 7.220.240** requires each employee of a hemp retail store to obtain a work identification card.
- **Section 7.220.280** establishes a semiannual license fee based on gross revenue.
- **Section 7.220.300** establishes duties of the licensee.
- **Section 7.220.310** establishes hemp retail store regulations.
- **Section 7.220.340** allows for investigation, inspection and audit of hemp retail stores.
- **Section 7.220.350** allows for enforcement of this chapter and penalties for violation.
- **Section 6.10.020** adds hemp retail stores to the list of businesses where work identification cards are required.

In accordance with NRS 237.080, business owners and interested parties may submit data and arguments to the Clark County Board of Commissioners, in care of the Department of Business License as to whether the proposed amendment will:

1. Impose a direct and significant economic burden upon a business; or
2. Directly restrict the formation, operation or expansion of a business.
