Please be aware that this a paid service that CCFS DOES NOT pay for (the only exception to this is if the child was placed at Child Haven and the service was set up when the child transitioned to a foster home. This service is only for ONE WEEK and the foster parent would be responsible for any continued service after that week).
- MTM (Medical Transportation Management)
If you need assistance in getting the child in your care to a medical appointment, you can request transportation assistance through Medical Transportation Management (MTM). This service is covered by Medicaid and can be set up through <https://www.mtm-inc.net/>
MTM can NOT be used for emergency services.
