VI. STAFF REPORTS:

Shooting Complex Briefing by Steve Carmichael

- A. Shotgun Center Kitchen – Now in the final steps of plan review and approval by SNHD. Opening soon.
- B. SNPLMA Round 19 update – Design meeting describing how NDOW grant will develop Archery 3D Trail with ADA access to multiple stations. SNPLMA funding will pick up from that point.
- C. “3rd Annual Best Shot in Nevada” – Spartan Arms providing all ammunition for rifles and handguns
- D. Introducing “Sunday Morning Greet & Skeet” – initial class December 7th; four (4) volunteer instructors; instructors will shoot with students and lead by example. Offered every Sunday morning.
- E. Event Attendance – NSTA Nevada State Trapshooting Championships experienced 50% attendance increase over 2024. Used 22 fields for six days and launched over 550,000 program targets.
