

Do I need a Clark County Business License?



PER **CLARK COUNTY CODE 7.200.040**, IT IS UNLAWFUL TO OPERATE, CONDUCT, CARRY ON, OR MAINTAIN ANY SIDEWALK VENDOR BUSINESS WITHOUT FIRST HAVING OBTAINED A VALID BUSINESS LICENSE ISSUED BY THE DIRECTOR.

ALL SIDEWALK VENDORS IN UNINCORPORATED CLARK COUNTY **MUST APPLY** FOR A CLARK COUNTY BUSINESS LICENSE PRIOR TO OPERATING .

STEP 1: Obtain a Nevada State Business License



STEP 2: Submit and Maintain a General Liability Insurance Policy



- ▶ A general liability insurance certificate issued by an insurance company authorized to do business in the state of Nevada must be submitted to the Director.
- ▶ The general liability insurance is a requirement per Clark County Code Title 7, Section 7.200.060 and is intended to protect the business if destruction of property, bodily injury, accidents, or death of a person is caused by the business. The form should list **Clark County, 500 S. Grand Central Parkway, 3rd Floor, Las Vegas, NV 89155** under the **Certificate Holder** section.
- ▶ Please note that “**Clark County**” should be named as an **additional insured** in the insurance policy and the policy limits shall not be less than:
 - ▶ *\$250,000 for bodily injury or death of one person*
 - ▶ *\$500,000 for bodily injury or death of two or more*
 - ▶ *\$50,000 for injury to or destruction of property in any one accident*

STEP 3: Provide Conveyance Specifications



The type of conveyance and a drawing or picture identifying the length, width and height are required.

Any conveyance operated by a licensee must not exceed 25 square feet.

All equipment, food, materials, and signs used for vending must be contained on or within the conveyance.

Any person shall file and thereafter maintain a general liability insurance policy issued by an insurance company authorized to do business in the state of Nevada. The general liability insurance policy shall name **Clark County** as an **additional insured**. The policy limits of such insurance shall not be less than:

- a. \$250,000 for bodily injury to or the death of one person in any one accident,
- b. \$500,000, for bodily injury to or death of two or more persons in any one accident
- c. \$50,000 for injury to or destruction of property in any one accident, fifty thousand dollars.

Each sidewalk vendor business must submit an insurance certificate to the Director that indicates that the county will be notified no less than thirty days prior to alteration, cancellation, termination or nonrenewal of such coverage.


