Did you know that instead of loading up your bulk items into your vehicle and driving down to the Republic Services Convenience Center you can put bulk items at your curb and we'll come get them?

Any item less than 50 lbs and under 6 feet in length that does not fit inside your wheeled carts can be placed next to your cart for pick up in Searchlight, Nevada on your trash service day.

Trash, recycling, and bulk items are picked up at different times throughout the day. The driver will collect your trash and dump it at the landfill before coming back to collect your recycling. All recycling will then go to the recycling center for processing.

If you find yourself needing a third wheeled cart, Republic Services will provide you with a third cart free of charge. A fourth cart is available for an additional fee, please call 702-735-5151 to request any additional carts.

Palm fronds are considered a bulk item and need to be tied up and neatly placed at the curb for pick up. Household appliances and other items that do not fit in your carts are also considered bulk items and will be collected on your scheduled pickup dates.

Refrigerators and air conditioning units are considered hazardous waste due to the freon contained in them and cannot be picked up by Republic Services.

If you decide you want to deliver your bulk items to the Republic Services Convenience Center instead of leaving them for us to pick up, please remember to tarp your load.


