- There is no fee for the initial or an annual inspection; the inspection fees apply to source re-inspections.
- Permit issuance fees apply to all minor source permits and minor source general permits.
- The ANEU07 fee is used as a generic emission unit fee code and is applied to any emission unit that does not have a specific fee code listed in Section 18.
- Per AQR 18.6.2.3, Each Stationary Source Subject To Federal Performance Standards Shall Pay An Annual Part 70 Emissions Fee.
