Statement by the Director of Business License

All licenses, permits or findings of suitability are conditioned upon compliance with all provisions of Zoning, Building, Fire or other Codes, State Gaming Statutes and regulations as applicable, Health Department regulations and the payment of Business License fees and investigation fees, as required by Ordinance or Regulation, unless specifically waived in code.

Licenses approved by the Director may not be activated until a final inspection and sign-off are received from an Agent of the Department of Business License.

Any Liquor License not placed into operation within sixty (60) days of the Director approval is automatically revoked.

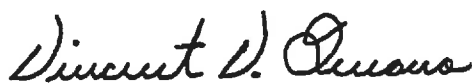

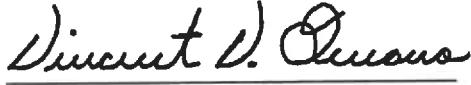

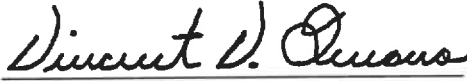

The Director **APPROVE** the request for a Transfer of Interest and a 6-month extension of the Preliminary Determination of Location Suitability for a Tavern Liquor License with Class A Gaming to expire on November 30, 2026, with the following conditions:

1. A tavern liquor license is contingent upon the land surveyor's diagram being correct in its distance measurement that the main entry door of the prospective tavern is not less than a 2000-foot radius from the main entry door of the nearest existing tavern and/or nonconforming tavern location.
2. No tavern liquor license shall be granted to any establishment located within one thousand five hundred feet of any entry onto an already existing school property (gate, door, driveway, etc.), any place wherein an already existing school is conducted, or within one thousand five hundred feet of any existing church.
