1. A tavern liquor license is contingent upon the land surveyor's diagram being correct in its distance measurement that the main entry door of the prospective tavern is not less than a 2000-ft. radius from the main entry door of the nearest existing tavern and/or nonconforming tavern location.
2. No tavern liquor license shall be granted to any establishment located within 1,500-ft. of any entry onto an existing school property, any place wherein a school is conducted, or within 1,500-ft. of any existing church, and the outside edge of children's public playgrounds.
3. No Preliminary Determination of Location Suitability for a Tavern Liquor License shall be granted if the prospective tavern is not less than a 2000-foot radius from the main entry door of an existing Preliminary Determination of Location Suitability for a Tavern Liquor License.
