AN ORDINANCE TO AMEND CLARK COUNTY AIR QUALITY REGULATIONS SECTION 101, "VOC EMISSIONS CONTROL FOR INDUSTRIAL ADHESIVE OPERATIONS," SECTION 102, "GASOLINE DISPENSING FACILITIES," SECTION 103, "VOC EMISSIONS CONTROL FOR MISCELLANEOUS METAL OR PLASTIC PARTS COATING OPERATIONS," AND SECTION 130, "VOC EMISSIONS CONTROL FOR ARCHITECTURAL AND INDUSTRIAL MAINTENANCE COATINGS," TO UPDATE, CORRECT, AND CLARIFY CITATIONS, DEFINITIONS, FORMATTING, AND ALTERNATIVE TEST METHOD REQUIREMENTS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

NOW, THEREFORE, THE CLARK COUNTY BOARD OF COUNTY COMMISSIONERS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Clark County Air Quality Regulation Section 101, "VOC Emissions Control for Industrial Adhesive Operations," Subsection 101.5(b), Table 1 is hereby amended as follows:

SECTION 2. Clark County Air Quality Regulation Section 102, "Gasoline Dispensing Facilities," Subsection 102.1(b) is hereby amended as follows:

(b) This section regulates the use of CARB-Certified Enhanced Vapor Recovery (EVR) as a contingency measure for achieving the 2015 National Ambient Air Quality Standard for ozone as required by Section [173]172(c)(9) of the Act under 42 U.S.C. 7502.

SECTION 3. Clark County Air Quality Regulation Section 103, "VOC Emissions Control for Miscellaneous Metal or Plastic Parts Coating Operations," Subsection 103.3 is hereby amended as follows:

"Projected maximum emissions" means the highest annual rate, in tons per year, at which the stationary source is projected to emit VOC based on anticipated production, throughput, heat input, or material utilization rates *that does not include emission reductions from add-on controls*.

• • •

SECTION 4. Clark County Air Quality Regulation Section 130, "VOC Emissions Control for Architectural and Industrial Maintenance Coatings," Subsection 130.3 is hereby amended as follows:

Unless the context requires otherwise, the following terms shall have the meanings set forth below for the purposes of this section. When a term is not defined, it shall have the meaning provided in Section 0 of the Clark County Air Quality Regulations (AQRs), Chapter 445B of the Nevada Revised Statutes (NRS), <u>The Clean Air Act</u> (the Act), or common usage, in that order of priority.

• • •

"Wood coating" means a coating formulated for application only to wood substrates. This category includes:

- 1. Clear and semitransparent coatings:
 - Lacquers;
 - Varnishes;
 - Sanding sealers;
 - Penetrating oils;
 - Clear stains;
 - Wood conditioners used as undercoats; and
 - Wood sealers used as topcoats.
- 2. Opaque [wood] coatings:
 - Opaque lacquers;
 - Opaque sanding sealers; and
 - Opaque lacquer undercoats.

. . .

SECTION 5. Clark County Air Quality Regulation Section 130, "VOC Emissions Control for Architectural and Industrial Maintenance Coatings," Subsection 130.4.1(b) is hereby amended as follows:

(b) On or after December 31, 2025, n[N] o person shall supply, sell, offer for sale, repackage for sale, apply, or solicit for application in Clark County any coating [that is manufactured or blended on or after December 31, 2025,] with a VOC content exceeding the limit in Table 1.

SECTION 6. Clark County Air Quality Regulation Section 130, "VOC Emissions Control for Architectural and Industrial Maintenance Coatings," Subsection 130.6.3(a)(1)(A) is hereby amended as follows:

(A) The VOC content of a coating must be determined using EPA Method 24, formulation data, other reasonable means for predicting that the coating has been formulated as intended (e.g., quality assurance checks, recordkeeping), or another test method demonstrated to provide results acceptable for determining VOC content <u>and as required in Section 130.6.3(b)</u>.

SECTION 7. Clark County Air Quality Regulation Section 130, "VOC Emissions Control for Architectural and Industrial Maintenance Coatings," Subsection 130.6.3(a)(2)(E) is hereby amended as follows:

(E) Another test method demonstrated to provide results acceptable for determining the VOC content of exempt compounds <u>and as required in Section 130.6.3(b)</u>.

SECTION 8. If any section of this ordinance, or portion thereof, is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 9. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases, or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 10. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.
