1. Receive a report and updates from the South County Liaison Mark Moskowitz on the Back to School Health and Wellness Fair from August 2, Clark County designation as a Public Heart County and any other updates from Clark County. (For discussion only)

Mark Moskowitz provided information on the Health and Wellness Fair that was held on Saturday, August 2^{nd} . He wanted to thank the partners who helped make the Health Fair a success. There are backpacks still available, contact our office to find out where to pick one up.

Mark Moskowitz spoke of the Purple Heart Trail. The purpose of the Purple Heart Trail is to create a symbolic and honorary system of roads, highways, bridges, and other monuments that give tribute to the men and women who have been awarded the Purple Heart medal. There are 13 honorary roads in Nevada.

It was mentioned that Fred Doten, who serves on this Town Board, is a recipient of the Purple Heart.

Mr. Moskowitz shared pictures of the signing of the new name of Laughlin's first bridge to *Donald J. Laughlin Bridge*. He thanked Carrie Larson and the Chamber for their work helping to make this change.

5. Receive a report from Andrew Bennett, Clark County Director of Traffic Safety regarding the development of the Safe Streets for All Southern Nevada Action Plan. (For discussion only)

Andrew Bennett and Daniel Fazekas provided a presentation that included the objectives and study areas. The death rates have been increasing with more deaths from 2019-2024 with pedestrians, bike riders or motorcycles.

A project overview was discussed with three phases, starting June 2025 and ending May 2026.

A survey was provided for the public to stay engaged and participate.

6. Receive a report from Louis Lacy and Alyssa Johnson with HELP of Southern Nevada regarding resources and programs available to the community. (For discussion only)

HELP provides information and outreach programs for the homeless, low-income residents, and the youth who are aging out of foster care.

They work with Metro officers with the homeless and provide better living conditions for the homeless.

HELP provides weatherization for residents who may need windows replacements, air-conditioners and heaters. Help with electric and gas payments.

Help people enter the workforce.

Help homeless youth 18 to 25 years old to find housing and work.

There is a diaper bank for new mothers, that includes formula, car seats, pack and play sets and parent classes.

HELP assist people to get their I.D., social service card, SNAP benefits and Medicaid.

Diversions: July 2025: 290 - acre feet. 2025 Total diversions: 1819 - acre-feet

Water System Update:

Staff repaired the chemical analyzer drain lines and cleared brush from those sites. The lower decant pond is being staged for draining and cleaning.

Water Resources Development Act (WRDA): Authorization for \$29 million for BBWD improvements passed the House and Senate in late 2024. Staff continues to work with U.S. Army Corp Engineers on 219 Environmental Infrastructure program. A letter was submitted of intent to facilitate the design phase of one 2MG storage tank.

Bronson Mack with Las Vagas Valley Water District spoke about the three public workshops regarding rate increases. Big Bend is still taking public comment and will be back at the September 9th TAB meeting with additional information.

Receive a report from Will Smith with Clark County Water Reclamation District regarding the status of the 8. wastewater system. (For discussion only)

The Laughlin Water Reclamation Facility treated an average of 50.623 MGD, producing clean water returned to the Colorado River.
