





- ❖ Open the Clark County website ([www.clarkcountynv.gov](http://www.clarkcountynv.gov))
- ❖ Under “Government” link, in the middle column, click on the “Justice Courts” link




- ❖ The Justice Courts “Jurisdictions” page displays a list of all courts. Scroll down to see all.




- ❖ Search for a desired Justice Court, hover over their button (it will change the color to blue and display the Court's address) and click to open their Home Page

- ❖ Read the disclaimer and click on the “Click here” blue button to open the Court Calendar.




