# **Contract & Interlocal Agreement Management**

- Awarded an Interlocal Agreement to the U.S. Geological Survey (USGS) for an assessment of post fire rehabilitation in desert tortoise habitat, Project No. 808A.
- Terminated an Interlocal Agreement with the U.S. Fish and Wildlife Service (USFWS) for the collection and disbursement of Section 7 mitigation fees. Effective July 1, 2010, the Bureau of Land Management (BLM) began collecting Section 7 mitigation fees in coordination with the USFWS.
- Awarded Amendment No. 1 to Partners in Conservation to reduce the scope and fees associated with volunteer support for BLM roads monitoring, Project No. 577.
- Received Board of County Commissioner approval to submit a request to the Southern Nevada
   Public Lands Management Act Office to change the scope of Project No. 499 to focus on correcting
   land surveys along the Virgin River.

### **Other Administrative Accomplishments**

Received Board of County Commissioners authorization to submit an application to the
Department of Motor Vehicles for a specialty license plate to promote the conservation of the
desert tortoise and to help offset program costs.

- Completed quarterly reporting required for Southern Nevada Public Lands Management Act (SNPLMA)-funded projects.
- Completed a review and reconciliation of all awarded, encumbered and expended funds from 1999 to present against the General Ledger for the purposes of calculating the minimum required expenditure and mitigation credits earned for the 2011-2013 biennium and to use in a 10-year summary report.
- Converted all permittee monthly mitigation fee remittance from checks to automated clearing house remittance to save staffing costs.
- Completed final budget projections for 2011 County fiscal year and prepared for closeout of the 2010 fiscal year.
- Completed DCP Administration budget for 2011-2013 biennium.
- Submitted Supplemental Account Reserve Request to SNPLMA for MSHCP Permit Amendment project.
- Submitted SNPLMA quarter three project status reports and financial projections.
- Developed and completed staff training on financial reporting database.
- Converted most outgoing letters from postal delivery to e-mail delivery.
- DCP has been working on the development of a "Change" module as part of the Case 360 project and contract tracking system. This module allows for automated change request processing, which is expected to improve efficiency related to receiving and processing contract change and amendment requests for the DCP's 50+ active projects/contracts. This effort, which began in November 2009, was completed in May 2010.
- DCP began work on a close-out module in May 2010, which will automate the close out review process for all projects and Purchase Orders in Case 360.

# **Document Reviews & External Agency Coordination**

- Requested cooperating agency status for Bureau of Land Management's (BLM) amendment to the Las Vegas Resource Management Plan
- Reviewed an Environmental Impact Statement regarding a proposed project at Walking Box and provided a comment letter
- Provided a letter to the BLM regarding deficiencies in impact analyses. Analyses are failing to
  account for the loss of Clark County-funded conservation measures to mitigate impacts anticipated
  in the MSHCP. A project proponent must be required to mitigate not only for the impacts of its
  project, but also for the loss of the conservation measure funded by Clark County, which was to
  mitigate the impacts of development on non-federal land.
- Provided a letter to the California Public Utilities Commission regarding the NextLight Silver
   State solar development solar project proposed in the Jean Lake area, which is undergoing the



development of a draft Environmental Impact Statement. Clark County purchased the Jean Lake grazing allotment for \$99,008.33 and worked with the BLM to retire grazing in this area to mitigate impacts anticipated in the MSHCP and to protect and improve the quality of covered species' habitat. It appears that a portion of this area may now be developed for solar and a portion of the conservation measure and its intent will be lost permanently. The project proponent must be required to mitigate not only for the impacts of its project, but also for the loss of the conservation measure funded by Clark County, which was to mitigate the impacts of development on non-federal land.

# Acquisition & Management of Acquired Easements, Property, Grazing Rights & Water Rights

- Initiated Grant of Options to purchase the Henrie Property from The Nature Conservancy
- Continued working with Real Property Management on updated surveys of Boulder City Conservation Easement (BCCE) expansion boundaries
- Filed a Notice of Appeal with the U.S. Department of the Interior Board of Land Appeals regarding disputed corridors reserved by the BLM within the BCCE
- Provided 439 hours of law enforcement patrol in the BCCE
- Traveled 6392 miles patrolling the BCCE
- Made contact with 83 visitors to the BCCE
- Issued one warning for illegal activities and one citation for illegal activity

#### **Desert Tortoise Transition**

- As of January 1, 2010, the DCP no longer collects pet desert tortoises and has spent the last several months transitioning that effort to the San Diego Zoo. The DCP is focusing its efforts on wild desert tortoises. This transition has been highlighted through direct mailings and a media campaign.
- In late May, the DCP distributed an e-card to our interested parties list of over 200 people, promoting the proper surrender of pet desert tortoises to the San Diego Zoo's new tortoise pickup line (702-488-9422). The media effort to promote this change, which kicked off in March, will resume in August.
- The DCP has collected 14 wild tortoises and/or stray pet tortoises on the fringe of development through the Wild Tortoise Assistance Line since the transition. This number is consistent with the number of wild tortoises collected in past years for the same timeframe.
- DCP continues to participate in the Pet Desert Tortoise Working Group to resolve community issues that have arisen due to desert tortoises allowed as pets. The group meets approximately once a month.



• DCP ran two ads (in April and May) promoting proper actions related to desert tortoises when encountered in the wild (do not touch or harass them, and if they are collected they must be surrendered to the DCP's Wild Tortoise Assistance Line at 702-593-9027). This media effort will also resume in August.

# **Wild Desert Tortoise Assistance Line**

- The line logged 37 calls
- Eleven (11) wild tortoises were collected and transferred to the Desert Tortoise Conservation Center
- One (1) non-desert tortoise was collected and transferred to the Desert Tortoise Conservation Center

### **Public Information and Education**

- Mojave Max Education Program Held field trip for winner of 2010 Mojave Max Emergence Contest. Wrapped up annual Mojave Max Education Program which correlates with the school year. During the 2009-2010 year, 20,707 students, 948 teachers and 114 schools received a Mojave Max Education Program and 6,100 students entered the 2010 contest.
- Mass Media Campaign Concluding 2009-2010 Stay on the Trails and Mojave Max ad campaigns
  with BLVDS magazine and KNPR and the Las Vegas Review Journal (Business Press, LVRJ Sports
  Page, Mesquite Local News and El Tiempo publications.) Initiating 2010-2011 advertising campaigns with the same media organizations.
- Pet/Wild Tortoise Campaign Continued print advertisements providing messages: "leave it wild",
  "I'm back in the wild because you dialed" and "pets don't belong in the wild". Print advertisements continue to run in these Las Vegas Review Journal publications. (The Views, Boulder City
  Review, Mesquite Local News, El Tiempo and CERCA publications.) Evaluating future advertisement
  campaigns, postcards and development of a pet tortoise video.

# **Desert Tortoise Fencing**

• Monitoring and Maintenance of Fencing (Existing Contract) — Under current contract with Nevada Division of Forestry (NDF) and with the approval of Nevada Department of Transportation, Clark County directed NDF to walk and repair all existing tortoise-proof fencing (350 miles) on a one time basis. NDF will provide ARCGis Shape files of all fencing walked, points where maintenance occurred, type of repair made, materials used and any other special incidents. All work encompassed under the current NDF contract will be completed or will cease by the end of the current contract, November 15, 2010.

### **Permit Amendment**

- Investigated the development of a construction worker education class
- Investigated the development of desert tortoise handling and authorized biologist training class in conjunction with US Fish and Wildlife Service
- Held three (2) meetings of the DCP Community Advisory Committee (CAC). The CAC has been working developed draft recommendations for revising the overall conservation strategy, including draft minimization measures and a draft Reserve System. Anticipate that the CAC will complete its work in September or October of 2010.
- Continued working to complete an agreement regarding the establishment of an off-highway vehicle licensing program with the Department of Motor Vehicles
- Continue to coordinate permit amendment progress with Permittees on a monthly basis
- Worked with PBS&J and ICF to develop draft proposals for minimization and mitigation in preparation for presentation to the CAC
- Met with BLM and FWS to discuss permit amendment and related issues, including a proposed revision to the Reserve Strategy
- Draft amended MSHCP projected to be completed Spring 2011
