**From Glenn Brook:**

**What has not been well acknowledged publicly were the officers that were on duty on the concert grounds. Not all OT officers had body cams (myself and other detectives that thought they were having a fairly easy OT gig), but the video you obtain from the department has video that will show the different circumstance that we were under compared to the officers who were responding - many after the gunfire stopped. Also the hero's behind the scenes - dispatchers, CSI, Homicide Detectives, Coroners Office, trauma therapists, etc.**

- 1) Have an area listing or with interviews the 49/50 officers (list can be obtained through LVMPD of who was working specifically RTE91 for OT) and their positions, who evacuated 25,000 concert attendees while they were under fire. OT officers were first on the scene for dead and wounded while being fired upon (and not knowing if there was one or multiple gunman) - along with many off-duty first responders as well as the concert goers themselves.**
- 2) Ask each officer for a donation of something they may have been worn or used to be displayed. I wore a baseball hat that to this day, people saw and tell me I evacuated them because my hat was light colored.**
- 3) My partner for the night, Det. Steve Balonek, identified the floor the suspect was shooting from, getting on the radio so officers could be dispatched to the area.**
- 4) Acknowledge: Dispatchers, Paramedics, and medical who responded**
- 5) Acknowledge: Homicide detectives, Crime Scene Analysts, Coroners office and others responsible in the aftermath of the shooting.**
- 6) The only cover my OT partner and I had was my work pick-up truck - which we had to stop from being stolen (this happened to many officers) while we were under fire and figure out what was going on and come up with a plan.**
- 7) Steve and I were able to evacuate people from the rear of the stage and others that were hiding beneath it to behind my truck or push them towards the tour buses and out towards McCarran Airport. Again, all the while under fire.**
