From Tara Roe's Family:

Hello committee members-

I would like for the thoughts of Tara Roe's family (one of the 58) be on record. Could you please read this email and take their wishes into consideration? Thanks for all you do!

Here is how they feel;

We have no further ideas or suggestions for the memorial site. Our thoughts of what we wish it to be were expressed in the survey. It doesn't need to be overthought or overdone, just keep it a place to offer peace, place of quiet reflection and of place of calmness. We remain vigilant in not wanting religious symbols or verses. Family has done what they wanted in terms of religion where there loved one was buried or placed. This memorial sight should be neutral (absolutely nothing saying 58 Angels for sure). Certainly nothing depicting a strong USA presence (4 Canadians were killed there, we feel that sometimes that is forgotten). Mostly we hope that the memorial site is kept somewhat apart from the area you want to honor the first responders and others connected. It will be unbearable to see "Vegas Strong" anywhere near where our Tara's name is. We are so far away but then so are so many of the other 57 victims' families. That must always be foremost on the minds

of the decision makers. No one in Las Vegas should look at it as what does "Las Vegas" want it to look like.
