Discussion

Deborah expressed one of the items she is hearing from 4H and Rotary, Park service is putting a garden in at the park like we had planned prior. We would like a motion to move forward with this project (Butterfly Garden). Kathleen expressed we had tried to get this project started before we just need to move forward and make this happen. Discussion was held on what specifically we need to start with. Public Land Day always has a project but Fred feels we need to address other issues in the park prior to the project. Meeting was sidetracked to other issues and Deborah brought it back to the project of the seed balls. Anna (phoned in) was asked to address the making of the Seed Balls, how long will they last ect. Preferred native seeds and there is location in Boulder area that could provide seeds along with plants for these projects, any soil will work, clay and then water to help bind them and they dry in a couple of hours and stored in 5gal buckets around 36 degrees. She thinks it would be a great partnership project and needs to hear time line to work out staff for all their projects. Question is how long will the seed balls store-- Anna has kept them up to one and half years as long as they are not in direct sunlight. A suggestion was made by Renee if we needed to use them, we could put them in the community garden.

Motion made to have the garden as our project.

Suggestion was made by Victoria that there is a point person not Deborah – but Deborah and Fred are the two with the best knowledge to direct this project.

7. Discuss and develop activities for a National Public Lands Day Event to be held at Pyramid Canyon Park in the Colorado River Heritage Greenway Park and Trails on September 28, 2024. (For possible action)

Location of the seed ball should be in the dirt area. Supplies needed will be potting soil, clay, water and buckets. Mark would like a list and he could possibly get some of the items from a contract with Home Depot. Per Anna a little goes a long way as for the soil and clay so approximately 3-4 bags of soil, powder clay is used. The seed Balls should be the size of a meatball or tennis ball. Best to mix in bus boy bins, Tarp could be used for laying the seed balls out to dry and then placed in aluminum trays to store them. The working bins will be provided by Anna. Anna will have at least one volunteer and is looking forward to being part of the projects in our area.
