#### 1. WS-23-0044-RAWSON CASEY & KATIE:

WAIVERS OF DEVELOPMENT STANDARDS for the following: 1) full off-site improvements (curb, gutter, sidewalk, streetlights, and partial paving); 2) drainage study; 3) eliminate street landscaping, screening, and buffering on 1.9 acres in the R-T (Manufactured Home Residential) Zone in conjunction with a minor subdivision map in the Moapa Valley Overlay District. Generally located on the south side of Paul Avenue and the west side of Yamashita Street within Moapa Valley. MK/jud/syp (For possible action)

Casey Rawson appears as the applicant. Discussions of what can and cannot be waived. Mr. Burris opposes waiving drainage study, as does Mrs. Hall. There were questions regarding a Restricted Covenant, they were unclear. Mr, Stussy is okay with all waivers, except for the Drainage study as his property is in the area. He feels this could compound the flooding at his Property. Ms. Ridondo states, it is a Public Works issue. Also, they need to do a parcel map first, and then the drainage study. Mr. Burris encourages them to reach out to the Commissioner. Mr. Burris makes a Motion to approve the waivers of offsite improvement, but deny the waiver of the drainage study.
