#### **SETTLEMENT** A.

# 1. LAS VEGAS PAVING CORPORATION (DCP #40460)

NOV #8447 – For allowing visible emissions of particulate matter to exceed 50 percent opacity; for allowing mud or dirt to be tracked out onto a paved road exceeding 50 feet from the point of origin; and for failing to have a Dust Monitor present at all times during a routine site inspection on July 2, 2013 at the Northern Beltway, Tenaya to Decatur construction site, located at Jones Boulevard and the Northern 215 Beltway, in Clark County, Nevada.
