DELIVERING RESULTS TO DISTRICT F RESIDENTS

SUPPORTING SMALL BUSINESSES

Commissioner Jones worked to launch 3 rounds of Small Business Stabilization Grants, awarding up to \$30,000 for working capital. Team Jones also hosted the Small Business Talk series with Congresswoman Susie Lee and Treasurer Zach Conine to discuss resources and information for small businesses in Southern Nevada.

We partnered up with the Legal Aid Center of Southern Nevada to start the 'Small Business Legal Advice Project-Helping Businesses During #COVID19'. This unique program in Nevada offers free legal advice to small business owners facing financial hardship due to the pandemic.



PROTECTING OUR ENVIRONMENT

Commissioner Jones has led efforts to protect Red Rock Canyon, supporting efforts to expand the National Conservation Area by thousands of acres. He has also worked to fund and build more parks, trails, and bike lanes in District F.

Commissioner Jones led the Commission to pass a resolution supporting protecting 30% of our lands and water in Nevada and the United States by 2030.

Commissioner Jones also helped launch 'All-In Clark County', an action plan to address climate change and create a more sustainable future for all. A long-term goal to reduce greenhouse gas (GHG) emissions 100% by 2050.




COMBATING THE EFFECTS OF COVID-19

Team Jones hosted over a dozen vaccination events this year, including "Vaccines After Dark" at the Welcome to Las Vegas sign and at AREA15, a vaccine event in partnership with the Southern Nevada Health District and Pinches Tacos, and one event at the Las Vegas Ballpark. In total, our vaccine events resulted in thousands getting their COVID-19 vaccine.


In partnership with Chair Kirkpatrick, Team Jones hosted an episode of "COVID Conversations" where doctors and public health experts in our community answered questions and dispelled myths about COVID-19. In the second episode, two survivors of COVID-19 discussed their experiences having the virus, misinformation they've heard within their communities, and the benefits the vaccine had in their families.

Through a resolution proposed by Commissioner Jones, Clark County became one of the first local jurisdictions to declare COVID-19 misinformation a public health crisis. COVID-19 has had a devastating impact on our economy, our children's education, and the health and safety of our community, and the spread of false and misleading information has only made matters worse. It's important for the County to commit to doing all we can to combat the falsehoods that continue to jeopardize the lives of our citizens.

GIVING BACK

- Partnered with the Culinary Academy of Las Vegas to host 5 food drives in District F.
- Co-hosted a blood drive with the Red Cross at the Las Vegas Ballpark to collect 99 units of blood which will save hundreds of lives.
- With over a dozen vaccine drives, we had the opportunity to vaccinate over 1,200 District F residents.
- Joined Rep. Lee, Assemblywoman Brittney Miller, and the Legal Aid Center of Southern Nevada to host a discussion on evictions and rental assistance.



- Hosted numerous eviction clinics for those who were facing eviction or in need of information relating to housing security.
- Voted for a historic investment of more than \$150,000,000 to fund desperately needed affordable housing in Southern Nevada.
- Voted for a resolution lowering development fees to incentivize the development of more affordable housing projects throughout Southern Nevada.
- Hosted helmet and bike giveaways to promote safety to children and teens.
