AN ORDINANCE TO ADOPT THE DEVELOPMENT AGREEMENT WITH GRAGSON FAMILY MANAGEMENT TRUST ETAL & TORRES ROBERT TRS & G K ACQUISITONS LLC ETAL & MICONE MICHAEL A TRUST FOR A MULTI-FAMILY DEVELOPMENT ON 7.82 ACRES, GENERALLY LOCATED NORTH OF MAULE AVENUE AND EAST OF GAGNIER BOULEVARD WITHIN SPRING VALLEY, AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

SECTION 1. SECTION 2. If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks and shall be effective on and from the fifteenth day after passage.
