# New Application for Certificate of Exemption Requirements

- Detailed description including but not limited to any horticultural and /or scientific information and background information which supports the claims that the cultivar is entitled to an exemption.
- Provide current DNA tree testing results as proof the trees are low or non-pollinating at the time of application. The sample shall be representative of the cultivars grown to be sold in Clark County.
  - Provide one additional current DNA test result, 18 months after the exemption is granted, to ensure the cultivar is true to type.
- Commercial distribution plan for the cultivar requesting exemption in Clark County.
- Sample tree tag to be approved by the Control Officer which must:
  - Show exempt status.
  - Include the date of most recent approval of Certificate.
  - Accompany the tree from inception through delivery to consumer.
  - Be easily visible by retailers and consumers.
- Any other information which the Control Officer deems appropriate.

## Renewal Application for Certificate of Exemption Requirements

- Commercial distribution plan for the cultivar requesting exemption in Clark County.
- Invoices or names of retailers in Clark County who have purchased low pollinating olive trees you produce.
- Provide current DNA tree testing results as proof the trees are low or non-pollinating at the time of application. The sample shall be representative of the cultivars grown to be sold in Clark County.
  - Provide one additional current DNA test result, 18 months after the exemption is granted, to ensure the cultivar is true to type.
- Sample tree tag to be approved by the Control Officer which must:
  - Show exempt status.
  - Include the date of most recent approval of Certificate.
  - Accompany the tree from inception through delivery to consumer.
  - Be easily visible by retailers and consumers.
- Any other information which the Control Officer deems appropriate.
