OVERVIEW

Clark County Public Arts Program

Annual Report: Fiscal Year 2025 | Outlook: Fiscal Year 2026

The Clark County Public Arts Office (Public Arts), a division of the Department of Parks and Recreation (P&R), advances the County's cultural priorities through the strategic implementation of the **County Arts Plan (Arts Plan)**. This is achieved through program development, public-private partnerships, and targeted communications. Public Arts serves as the primary liaison for numerous County cultural initiatives and implements policies that support the mission of enriching the lives of residents and visitors through public art.

While Clark County currently does not have a formal cultural planning document, the cultural affairs staff within P&R strongly advocate for this investment. A comprehensive plan would enable coordinated efforts aligned with the needs and interests of the diverse communities we serve.

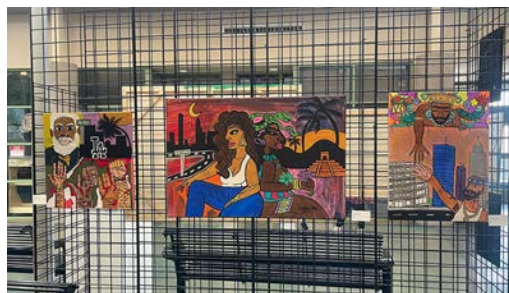
This **Annual Report** outlines activities and associated funding for **Fiscal Year 2025** and introduces proposed initiatives and budgetary direction for **Fiscal Year 2026**. Budgets referenced reflect full project lifecycles and may span multiple fiscal years. Some projects may not have incurred expenses during this period due to development timelines or fiscal policies; however, they remain active as staff and the Evaluation Committee continue progress on artist calls and project planning.

The Arts Plan represents one of the key avenues through which Clark County invests in the cultural and artistic development of its communities.

Mission Statement

The mission of the Clark County Public Arts Office and Public Art Advisory Committee is to advance arts, culture, and creativity through commissioned public arts, fostering a vibrant cultural identity in our community and beyond.



HISTORICAL CONTEXT

The Percent for the Arts Program and its associated Art Fund were established on July 17, 2012, with the Clark County Board of County Commissioners (BCC) approving the first Arts Plan on December 4, 2012. This authorized the allocation of funds from the Room Tax Collection Commission and the Special Ad Valorem Capital Projects Tax, effective January 1, 2013. Clark County hired its first full-time Public Arts employee by August 2013.

Subsequent milestones include:

- Funding for the Poet Laureate Program (added October 17, 2017)
- Additional full-time staff allocations (December 2019, July 2023, August 2024)
- Ordinance amendments in FY23: removal of the annual audit requirement and increasing the annual funding cap to \$2.25 million

PUBLIC ART PROGRAMMING & SCOPE

Permanent public art remains a top priority. Public Arts focuses on equipping local artists with the skills and opportunities to compete for large-scale public art commissions. The division oversees:

Temporary art installations

- Commissioning and conservation of permanent works throughout 8,061 square miles of unincorporated Clark County
- Temporary art installations
- Management of three funded galleries
- Youth and adult education programs
- Portfolio review initiatives
- Special projects and committee advisement beyond Arts Plan allocations

Collaborative partnerships include:

- Wetlands Park: shared gallery and artist residency programming, annual sculpture projects
- Winchester Dondero Cultural Center: shared gallery and storage space
- Clark County Museum: exhibition collaboration at the Rotunda Gallery and guidance on historical artworks
- Nevada Museum of Art (Northern Nevada): \$50,000 annually to support Seven Magic Mountains maintenance through July 2027

As new works are acquired and accessioned into the Arts Plan collection, they contribute to Clark County's reputation as a culturally vibrant community.

Types of Artworks:

Paintings, murals, photography, sculpture, film, playground elements, and permanent public installations on County-owned property.

Clark County Public Arts Values

Foster Community Identity – Clark County Public Art reflects local culture and values, encouraging a unique sense of place and belonging.

Enhance Connection and Dialogue – Clark County Public Art unites diverse communities, sparks meaningful conversations, and enriches civic engagement by honoring the past, present, and future.

Transform Spaces – Clark County Public Art revitalizes neighborhoods, promotes economic growth, enhances public safety, and fosters cultural tourism, transforming spaces into dynamic communities.

The summary of activity is as follows:

SALARIES AND BENEFITS: One (1) Program Administrator (C29), one (1) Cultural Program Supervisor (C28) vacant, one (1) Public Art Conservation (C26) vacant, one (1) Recreational Specialist (C25), one (1) Office Specialist (C24) vacant and (9) part-time Program Assistants.

OPERATING EXPENSES: Art supplies, paint and painting supplies, graffiti coating, lights, office supplies and minor equipment.

Conservation: This report covers the survey of the existing public art collection, including necessary repairs and restoration efforts, and ongoing maintenance of current artworks.

During fiscal year 2025, five (5) active conservation projects for artworks were undertaken across the county's seven (7) districts. Of these projects, three (3) have been completed, with one (1) expected to finish by June 2025. The remaining project is anticipated to extend into Fiscal Year 2026.

Within Las Vegas, there is a total of four hundred and sixty-nine (469) artworks, of which two hundred and ninety-seven (297) are serviced by Gorilla Property Services on a monthly basis. The remainder of the public artworks throughout the county receives maintenance from a public art conservator on a monthly to bi-monthly schedule.

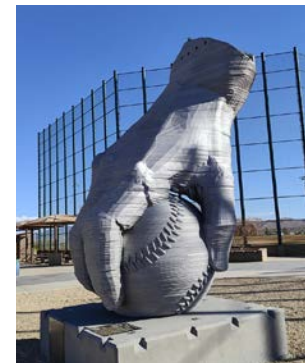

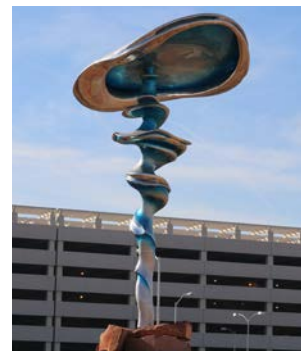

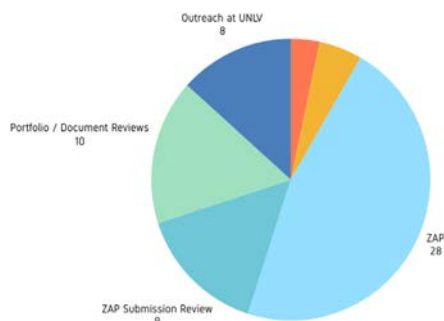
Full Scope

YOUTH EDUCATION

BUDGET: \$25,000

The Public Arts Office invited nine artists to participate in a professional development and mentorship program focused on public art. Five artists were chosen for the fall session and four for the spring. They received training in lesson planning, leading children's workshops, creating three-dimensional installations, and collaborative design.

Following their training, each artist conducted workshops at two Clark County locations and created a temporary traveling public art project. The work was displayed in a gallery at the Whitney Recreation Center for 4-6 weeks, where they handled transport, installation, and de-installation. The spring cohort will exhibit at The Gallery at the Winchester-Dondero Cultural Center. Throughout the program, artists developed project concepts, collaborated with County staff on logistics, and created installations that incorporated contributions from participating youth while enhancing their skills. In total, nine artists engaged 575 children within Clark County.

Budget: \$8,000 per year for a two-year term

The Poet Laureate program was dedicated to celebrating the literary community of Clark County and sought to enhance the literary arts by engaging with diverse populations. Ms. Ashley “Ms.AyeVee” Vargas fulfilled the role of cultural ambassador for poetry, undertaking public events throughout the County and representing the rich literary history and diversity of Southern Nevada. Her responsibilities encompassed participation in ceremonial, educational, and cultural activities, as well as fostering an appreciation for the literary arts through workshops, readings, panels, festivals, and public appearances. In Fiscal Year 2026 we will see Ms.AyeVee continue her great work and look forward to reading her commissioned poem that reflects her body of work during her tenure.



Ashley “Ms.AyeVee” Vargas is an award-winning Afro-Latina Literary Artist from Las Vegas, Nevada. She is a woman of many hats with a passion for Poetry. Her work has been featured by The legendary All Def Poetry, Write About Now & Button Poetry. She has also been recognized by the Las Vegas Book Festival, Nevada Public Radio, & The US Congress for advancing the cause of literacy & extraordinary literary achievement. In 2022, Ms. AyeVee was selected as an official TEDx speaker for Las Vegas. She also runs a Las Vegas-based poetry organization, Beyond the Neon (@btnpoetry), focusing on poetry-exclusive events and community outreach.

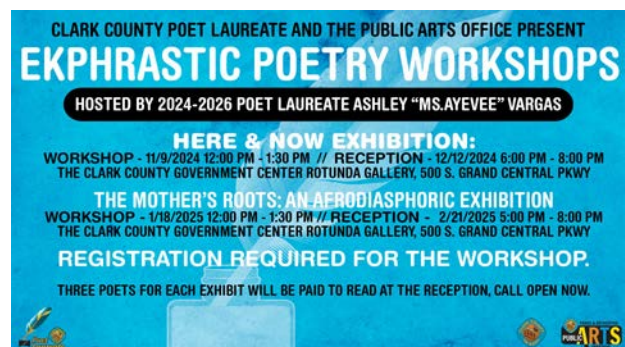
POETRY PROGRAMMING – ALL DISTRICTS

The SOLO SERIES is a gallery program that features four selected artists who will showcase their solo exhibitions at the Pearson Community Center. The selection process is guided by members of the Historic Westside, ensuring that the artwork resonates with and reflects the community's experiences and values. Each participating artist will also conduct a workshop at the center, allowing them to engage with the community and share insights related to their exhibitions.

This year, we received 25 applications, from which four talented artists were chosen. We were honored to have Naoka Foreman, a reporter from The Nevada Independent, serve as a special guest juror to assist in the selection process.

Looking ahead, in June 2025, following the SOLO SERIES program, we will host a juried group exhibition titled "Juneteenth: Some Red, Some Not," which will explore the theme of red foods. This exhibition aims to celebrate the rich cultural significance of Juneteenth through artistic expression.

COMMUNITY ENGAGEMENT & PREVIOUSLY FUNDED PROJECTS:

Project Funding

It is essential to recognize that funding for public art projects should encompass all expenses associated with each project to ensure its successful completion. This includes the artist's fees, consultation fees, unforeseen construction expenditures, and funding for dedications, including promotion and catering. By taking into account all expenses associated with the project, we can secure adequate funding and create something truly remarkable that will inspire and uplift our community.

Active Projects

While some projects have not incurred expenses the majority are active as staff seek advice, plans, feasibility, approvals, etc. from a multitude of sources. The list of steps prior to putting out the call to artist is extensive. These projects are considered active as they have staff assigned and actively working on them.

Public Art Evaluation Committees

Every project and program start with staff identifying stakeholders that can help create the call for artists. The evaluation committee, which usually includes representatives from the District Office, Neighborhood or Facility, and Public Art Committee, is responsible for much more than merely evaluating the proposed artwork. The committee creates a narrative for the artists about the community and/or facility, establishes base line for scope of work including making choices on materials and location of artwork, and establishes clear and achievable project goals.

Once the call fo artists is issued and staff have reviewed applications for completeness, the evaluation committee conducts a two-phase assessment. The artist selection process is intentionally thorough, equitable, and extensive to ensure the best candidate is chosen. The evaluation committee plays a vital role throughout the project, and the staff relies on them to help find agreement and make any necessary design changes.

Commission and Acquisition Projects

Commissioned projects are projects where the arts plan has funded the project completely. Acquisition Projects are projects that are using other or mixed funding sources other than the arts plan. It is important for all to understand that while this is a report about the arts plan funding staffing is a portion of this plan. When staffing is directed to project manage additional funding sources this takes time away from the arts plan assigned projects. It is important to capture all the activities that the arts plan staff are involved in.

Community Engagement: Fund to enhance arts and culture. To secure artists to participate in special events that are happening in the community or offer unique art engagement opportunities to the public. These programs or projects can result in permanent works of art added to the Arts Plan.

1. Salaries and Benefits:

Project: Program staff

Budget: \$531,608

Scope: One (1) Cultural Program Administrator (C29), one (1) Cultural Program Supervisor (C28), one (1) Conservator (C27), one (1) Recreational Specialist (C26), one (1) Office Specialist and nine(9) part-time Program Assistants.

In fiscal year 2025 Parks and Recreation hired on the Cultural Program Administrator, leaving the Program Supervisor Position to be filled. This position is currently being recruited as well as the full-time office specialist position. There is one additional position funded and the department is working with Human Resources.

2. Operating Expenses:

Project: Program operating supplies

Budget: \$300,000

Scope: Art supplies, paint and painting supplies, graffiti coating, lights, office supplies and minor equipment.

3. Conservation:

Project: Survey of the existing public art collection, repairs and restoration.

Budget: \$200,000

Scope: Assessment, maintenance and restoration of existing public art.

For fiscal year 2026, we anticipate six projects that will utilize conservation funding:

1. Seven Magic Mountains - District A: \$50,000 allocated to the Nevada Museum of Art for maintenance of the artwork for five consecutive years, starting in FY23 (currently in the 4th year). This budget was approved on July 19, 2023, under Agenda Item #40.

2. Norte y Sur - District A: The City of Henderson is constructing a pedestrian bridge on Eastern Avenue. As the artwork will be relocated during this process, it presents an excellent opportunity for a thorough examination and necessary repairs. The sculpture was damaged by a car this fiscal year and will need repairs once it is removed from the site.

3. Reach - District D: While phase 1 is completed under FY24 projects, the sculpture itself requires repairs. Staff have been in contact with the artists to discuss the next steps and formulate a restoration plan. We hope to begin repairs this year.

4. Octosteam - District E: Repairs are needed for damaged metal, as well as peeling and fading paint on the sculpture.

5. Jaguar - District E: Repairs are needed for fading and damaged paint on the sculpture.

6. Zap Maintenance: We are contracting a company to assist with the maintenance of all Zap projects within the Las Vegas Valley, excluding Zap 15 at the stadium.

4. Public Art Education:

Project: Art Education

Budget: \$40,000

Scope: Ongoing community art education programs

- Youth Education \$28,000
- Adult Artist Education \$12,000

5. Poetry:

Project: To promote poetry as an art form and as a means to engage the community.

Budget: \$32,000

Scope: To recognize a Poet Laureate within Clark County and to provide professional education to poets within our community.

- Poet Laureate \$8,000 per year
- Poetry Programming \$24,000

6. Galleries:

Project: Art Galleries

Budget: \$20,000

Scope: Galleries include Winchester, Rotunda, Wetlands and Pearson. Funding is used for gift certificates for best in show, honorable mentions, catering services, musicians, etc. and juror members time and/or artists fees through professional services.

7. Community Engagement:

Project: Community Engagement fund to enhance arts and culture.

Budget: \$80,000

Scope: To secure artists to participate in special events that are happening in the community or offer unique art engagement opportunities to the public. These programs or projects can result in permanent works of art added to the Arts Plan Collection.

Proposed projects include a call for artist for an upcoming Clark County Museum Exhibit, the next installment of the Empowerment Art at our community centers.
