



Clark County Board of Fire Code Appeals Application

(Note: This document and accompanying materials become public record once it is received by Clark County.)

Clark County Code (CCC) Section 13.04.070, Subsection 109 provides for the Clark County Board of Fire Code Appeals. The Board is established to hear and decide appeals of orders, decisions, or determinations made by the fire code official relative to the application and interpretation of the Fire Code of Clark County. The Board renders all their decisions and findings in writing to the appellant with a copy being transmitted to the fire code official.

The Clark County Board of County Commissioners (BCC) shall appoint nine (9) members to the Board:

- A Fire Protection Engineer registered by the State of Nevada.
- A Civil Engineer registered by the State of Nevada.
- A Fire Sprinkler Contractor licensed by the State of Nevada.
- A Fire Alarm Contractor licensed by the State of Nevada.
- A Representative of the Exhibit and Trade Industry.
- A Specialist in Fire Safety, as identified in Subsection 104.7.2 of Section 13.04.070 of the CCC.
- A Specialist in Hazardous Materials, as identified in Subsection 104.7.2 of Section 13.04.070 of the CCC.
- 1 Layperson; and
- The Fire Chief of the Clark County Fire Department

All members of the Board must be qualified by training and experience to decide matters relating to building construction. The training and experience of the Board members may include knowledge relating to hazards of fire, explosions, hazardous conditions, or fire protection systems. Moreover, the members of the Board may not be employees of the Clark County Fire Prevention Bureau.

Clark County is currently seeking applications for all positions mentioned above excluding the position represented by the Fire Chief of the Clark County Fire Department. All appointments to the Board will occur at a future BCC meeting, notification will be provided, and the appointments will be for a four-year term.
