## Business Enterprise Group Definitions

- **Minority Owned Business Enterprise (MBE):** An independent and continuing business for profit, which performs a commercially useful function and is at least 51 percent owned and controlled by one or more minority persons of African American (AA), Hispanic American (HA), Asian-Pacific American (AX) or Native American (NA) ethnicity.
- **Small Business Enterprise (SBE):** An independent and continuing Nevada business for profit which performs a commercially useful function, is **not** owned and controlled by individuals designated as minority, women, or physically- challenged, and where gross annual sales does not exceed two million dollars (\$2,000,000).
- **Veteran Owned Business Enterprise (VET):** An independent and continuing Nevada business for profit which performs a commercially useful function and is at least 51 percent owned and controlled by one or more U.S. Veterans.
- **Large Business Enterprise (LBE):** An independent and continuing business for profit that performs a commercially useful function and is not located in Nevada.
- **Woman Owned Business Enterprise (WBE):** An independent and continuing business for profit, which performs a commercially useful function and is at least 51 percent owned and controlled by one or more women.
- **Physically challenged Business Enterprise (PBE):** An independent and continuing Nevada business for profit which performs a commercially useful function and is at least 51 percent owned and controlled by one or more disabled individuals pursuant to the federal Americans with Disabilities Act.
- **Disabled Veteran Owned Business Enterprise (DVET):** A Nevada business at least 51 percent owned/controlled by a disabled veteran.
- **Emerging Small Business (ESB):** Certified by the Nevada Governor's Office of Economic Development effective January 2014. Approved into Nevada law during the 77<sup>th</sup> Legislative session as a result of AB294. Must hold a certificate to be recognized as an Emerging Small Business.
- **Nevada Business Enterprise (NBE):** Any Nevada business, which has the resources necessary to sufficiently perform identified County projects and is owned or controlled by individuals that are not designated as socially or economically disadvantaged.
