Water use for Mar. 2025 – 3.7MG Water use for Mar. 2026 – 3.97MG Increase of 270,000 Gallons. Asset Management Group completed their survey and did not find any other leaks. All leaks for the survey have been completed.

Rural System operators and Customer Care continue to reach out to customers regarding onsite leaks. Swamp Coolers do tend to trigger leak reports but still inspect your properties especially if the reported leak is above 0.5-gpm.
