## VI. Informational Items:

1. Receive a report and updates from the South County Liaison Mark Moskowitz, and any other updates from Clark County. (For discussion only)

Mr. Moskowitz wished everyone a Happy New Year everyone and welcomed Carrie Larson to the LTAB. He also introduced Kathleen Hickman who is replacing Tammy Harris in the Laughlin Administrative Offices.

He provided flyers and information for the upcoming events scheduled for Saturday January 31<sup>st</sup> with Commissioner Naft starting at 9 am. Coffee and Conversation at the Morning Joy Café. Followed by the Annual Laughlin Animal Vaccination Clinic from 11am – 1 pm at the Spirit Mountain Activity Center, registrations are required this year to help with the flow. Funding has changed, only Nevada residents will be allowed to register. We have worked with our neighbors across the river, and they will have other animal events occurring on the same day in Bullhead City. If you are unable to attend, the Animal Foundation provides low-cost vaccination clinics throughout the year. If you know any Vets or Veterinary Assistants who can help, please let me know so we can try to service more animals.

The Laughlin Library is hosting the Annual Laughlin Resource Fair on Wednesday January 28<sup>th</sup> at the Laughlin Library from 11am – 1pm. Mr. Moskowitz provided a flyer.

Nevada Legal Services comes here on the first Wednesday of every other month from 10 am – 2 pm and can help with legal questions and is a great service. Flyers and brochures are in the back.

Clark County Business License has a satellite office here on the first Wednesday of every month at the same time as Nevada Legal Services.

Clark County District A Tenant Improvement Grant Program is still accepting applications for the for small business owners up to 25K if the business meets criteria. Flyers are in the back.

UMC Online Connection Care is across the street, please use it, it's a great resource and they can get you a Teladoc appointment. Flyers are in the back.

I want to introduce Community Ambulance. Mark Calabrese (VP of Operations) said a few words; 2 units are housed in Laughlin, with 1 unit off Needles Hwy in the residential area, and 2<sup>nd</sup> unit is housed at Edgewater until they can find a 2<sup>nd</sup> area.

Jackie Wallin and Rene Yopez presented the award to the Las Vegas Metropolitan Police Department

MVP's. You've seen them in bright yellow shirts, but you know them best by their smiling faces and the reassurance they bring to our community. The MVP's meet any challenge asked of them.

3. Receive a report from Lt. Rogers with Metro Police regarding activity and statistics during the past month and other areas of crime concerns. (For discussion only)

Lt. Rogers reports that for 2025 we were down in all crime categories close to 30%. This includes burglary, commercial, forcible rape, robbery, burglary auto, grand larceny auto, assaults, burglaries to homes or hotel rooms, and homicide / murder, and same with stolen cars in residential areas and home break ins. There was an increase of 10% in Domestic Violence, we had 123 reports compared to last year. With that there was an increase in arrests and case closures by detectives. Our focus this year is through our Coffee with a Cop and through our community outreach to try and bring those numbers down for the domestic violence side of things. The goal for 2026 is to reduce the events that occur in people's homes in domestic violence.

Kathy Ochs inquires what the call volume has done with Nevada Made Marijuana at the mall since they closed. Lt. Rogers stated there has been a reduction, but we didn't have a lot of calls there, as they were required to have their own security on the property by State Law.

Coffee with a Cop at Harrah's Casino on January 14<sup>th</sup> from 11:00 a.m. – 12:00 p.m. in the Hacienda Grand Ballroom. We will also be having a guest speaker from the Financial Crime Section and will have a detective on site to answer questions.

On Wednesday January 28<sup>th</sup> we are doing a homeless count and offering services to them to see why they're homeless and how we can assist. If you have someone in your area, please let our office know.

LVMPD has done 9 blood drives year to date. Last year we brought in 262 Units of blood and 275 people took advantage of that.

Clark County has upgraded our Pre Plan System, with iPad's to enter information into, and will be able to access information quicker and get updated on the "fly" when doing monthly inspections.

The Whole Blood Program has started, and Clark County Fire Department Medical Chief is now carrying whole blood in their units for any traumatic injuries. CCFD is waiting to see if it will come to Laughlin. CCFD is working with Community Ambulance regarding operations in Laughlin.

Kathy Ochs inquired if Captain Quihuis will be here in Laughlin full-time. Captain Quihuis stated yes, this will be his permanent station for a duration.

The Big Bend Water District storage project remains on the State Revolving Fund Loan Priority list.

Water Resources Development Act (WRDA): Authorization for \$29 million for BBWD improvements passed the House and Senate in late 2024. Staff continues to work with representatives from U.S. Army Corp Engineers on 219 Environmental Infrastructure program. A letter of intent was submitted to facilitate the design phase of one 2MG storage tank.

Mr. Bailey just received word the funding BBWD requested for \$980,000 for the design of a tank that was approved by the House and by the Senate and has now been included in the final bill. It will go before sometime in the first quarter of this year. Any updates if it passes, he will let the board know.

Kathy Ochs inquires as to the national change that they have with regards to fluoridation of water, what will happen to Laughlin and what will be the outcome of that?

Jermaine Smith (BBWD Systems Superintendent) responded that he hasn't heard anything, but Nevada revised statute is 10K people and as long as we stay under 10K people we shouldn't have anything to do with fluoridation.
