## **SPECIAL NOTES**

During the term of the Clark County Public Works Qualified Products List (QPL) no new luminaires will be considered for inclusion. Only luminaires or tubes for 60-foot, 80-foot, 100-foot right of way streets, A1 intersection, A2 intersection and street name lighting that are replacing a discontinued luminaire on the QPL, which is currently in a corresponding category, will be considered for substitution in the QPL. Only one luminaire may be submitted for consideration as replacement for each luminaire that is being discontinued by the manufacturer.

Luminaires for streets greater than 100-foot right of way are not included in the Clark County Public Works Qualified Products List at this time. Documentation and lighting study for luminaire(s) for streets greater than 100-foot right of way must be submitted for review to Clark County Traffic Management Division. For streets greater than 100-foot right of way, only luminaires that meet or exceed current Clark County specifications will be considered for use in unincorporated Clark County.
