Dec. 2024: Water usage 2.7 MG.

Dec. 2025: Water usage 3.27 MG which is an increase of 570,000 G.

The Cottonwood Project did use some water in December so maybe part of that is the increase, but the project is now complete. The NDOT project did not pull any water in December. There were no main breaks or service line leaks to report.

In the next month the Las Vegas Valley Water District will have the Asset Management Group come out and do a Leak Detection Survey in Searchlight to see if they can find leaks. One property in Dec. was going through 24K gallons a day. Luckily, they were able to contact the individual and able to get it fixed.

Reminder when the temperatures are dropping, please remove your hoses from the hose bib and insulate them.

VI. Planning and Zoning:

VS-25-0850-TURNBULL, LLC:

VACATE AND ABANDON an easement of interest to Clark County located between Armed Forces Street and Gasline Road and between Gaviland Street and Check Ride Avenue within Searchlight. (description on file). (For possible action) To the PC 02/03/26

The applicant provided an exhibit and overview to the board members. The Airstrip south of town has an open drainage ditch which runs along the airstrip itself. Current easement language reads “public drainage easement with public maintaining it”. They would like to rededicate it to read “public drainage easement to be privately maintained”. The reason is to allow a box culvert to be placed into drainage ditch so that water flow can be there, but development can occur over that to allow airstrip to be redeveloped and useable, can’t be used as is.

Judy Bundorf: spoke about Walking Box Ranch and approval from BLM to buy materials and repairs are being made on the Barn. We are hoping to have docents on site several days a week for more tours, more cleanup, and potentially a caretaker in the future.

There have been a couple of hikes. Jan. 3rd one of the groups took a hike to one of the local mine sites.

Jack Schuler: When Republic was here (November) we found out about closing our Convenience Center to 1 day a month. In 2022 the Revised Contract was amended or updated. Original contract stated it would be at the Convenience Center 3 days a week 4 hours a day. Then in 2022 it changed to “a maximum of one Saturday per month for a maximum of 4 hours”. The worst part is if the county determines that additional days / hours are needed the Franchise will have the sole rite to establish rates and collect fees from residents for disposal of waste. It appears if we ask for more days we are going to have to pay for them. I want to know what the County thinks about this.

Jack Wheeler: Want to discuss the dump. Wants to thank those on Christmas Vacation who dumped all in one area trying to keep the desert clean. I am requesting the Town Board to write a letter to BLM about the dump being open one day a month for four hours. This happened 10-15 years ago, and BLM was out here trying to control it, but it became uncontrollable.
