Intake screens were cleaned by Blue Locker Divers to prevent flow restrictions.  
Staff responded to ten (10) customer service calls in November.

Water Resources Development Act (WRDA): Authorization for \$29 million for BBWD improvements passed the House and Senate in late 2024. Staff continues to work with U.S. Army Corp Engineers on 219 Environmental Infrastructure program. A letter was submitted with intent to facilitate the design phase of one 2MG storage tank.

1. Review, discuss, and approve the 2026 Laughlin Town Advisory Board meeting dates, and take any action deemed appropriate. (For possible action)

After a brief discussion the Board approved the dates as written. Upon a voice vote meeting dates approved for 2026. 4-0

2. Nominate and appoint five (5) members for Citizen of the Year Review Committee. (For possible action)

The LTAB voted themselves along with Judge Briscoe to be judges for the next Citizen of the year committee. Kathy Ochs motioned for approval, motioned passed. 4-0

3. Laughlin Town Advisory Board discuss and make recommendations regarding the use of Fort Mohave Development Funds for the funding of the additional water tank needs in the Township of Laughlin and other matters properly relating thereto. (For possible action)

After a brief discussion Kathy Ochs provided the TAB's recommendations to move forward with the proposed new water tank(s).

Motion to approve a conceptual loan for a cap amount of \$11 million from the FMDF for the following:

1. A hydraulic study conducted on the current water system infrastructure, capacity and addition of two water tanks for storage and public safety for Laughlin.
2. Design plan and estimated financial costs to build (2) two water tanks as needed in Laughlin.
3. These reports and design plans are to be completed by an independent third-party individual or company licensed within our jurisdiction, who will have full assistance and overview from our County Commissioner, LVVWD, and an elected designee from the Laughlin Town Advisory Board. The designee from the LTAB will be involved in the selection of the third party through the bid process, ongoing developments, final reports, financial expenditures, and plans reported to the public.
4. These report and design plans will remain the property of the FMDF.

5. There will also be ongoing grants sought out by the FMDF Capital Committee throughout the duration of the loan to offset cost to the community.
6. Current consideration of the loan terms:
  - A. 30-year term no interest
  - B. FMDF monies as Guarantor
  - C. Income to repay loan from growth connection charges, grants, public / private partnerships, and land lease revenues.

Upon a voice vote, motion unanimously approved as written. 4-0
