A. Call to Order -

C. Appeal Determination/Vote:

Ron Lynn clarified the reason for the appeal is to have a performance measure for the alarm testing of laundry rooms of 100 square feet or less, with the doors open.

A motion was made by member Bill Laub to approve the appeal. The motion was seconded by member Corey Wallace.

A vote was done by the members. There were four Ayes & two Nays. It was determined by Chairman Allyn Vaughn that the appeal is approved in favor of the appellants Daniel & Larry Miller.

Appellant Larry Miller asked to clarify what is being approved. Ron Lynn verified that the approval is being granted to test the alarm systems in laundry rooms 100 ft. or less with the doors open.

Appellant Daniel Miller asked if this approval only applies to this permit or future applications as well. Ron Lynn clarified that this approval is for this specific application, but to apply this to future applications, Assistant Fire Chief Cochran & staff will need to write a formal interpretation. Bill Laub asked if this approval refers to the current code or 2018s. Mr. Lynn stated it applies to current code, however, upon an amendment being done, the 2018 code may apply.
