Randy Willbanks announced CCFD received preliminary approval for their FRO, which is the first responder offensive training and will be available for the Valley. LVFR received preliminary approval for their project, which will be monitoring equipment replacement that will benefit LVFR and Henderson fire hazmat teams and Metro Armor. North Las Vegas received preliminary funding for mobile decontamination equipment that includes a mobile trailer that can be deployed anywhere. LVFR has completed the replacement of all decontamination equipment. Everyone's trained and the equipment is in service. The Las Vegas Valley Water authority donated a chlorine tanker that is available for training scenarios.
