#### Supporting Small Businesses

We have made great strides this year for the small business community in Clark County. Early on in Commissioner Jones' tenure on the Clark County Commission board, he worked to create Clark County's Office of Community and Economic Development to attract new businesses but to also support existing ones with local, state, and federal resources. This year, we are pleased to announce the new Technical and Economic Assistance Program (TEAP) for small businesses and non-profits within unincorporated Clark County. Small businesses and non-profits with 50 or fewer employees and \$3 million or less in annual revenue may be eligible to receive up to 13 months of customized **business** mentorship and financial assistance to support recovery, resiliency, and capacity building.

We have created new online tools to promote economic development as well. BusinessInClarkCounty.com is a one-stop shop for existing and prospective businesses to gather information about —

community, learn about potential fees for new projects, or verify proper zoning for a startup business.

There are real-time data points on the Southern Nevada economy and interactive map showcasing major developments in the With area. Chinatown in District F, we have ensured the website is available in seven Asian and Pacific Islander languages with more in the works!

#### **Parks**

There are great things planned for the parks in District F. The improvements include pickleball courts, soccer fields, an events center, and many other new amenities at Desert Breeze, James Regional, and Mountain's Edge Parks. The plans also include inclusive playground areas so kids of all abilities can enjoy the park.

This year, we also celebrated the grand opening of Southwest Ridge Park & Trailhead! The park includes a new neighborhood park with sidewalks, a playground, interpretive and education signage, a trailhead plaza, a parking lot, restrooms, and a turf area.






#### **Public Safety**

The southwest valley is much safer thanks to the recent completion of Fire Station 35 near Flamingo Road and Hualapai Way. The Howard Hughes Corporation funded the design, development, and construction of the new fire station and donated the land on which it sits as part of its development agreement with Clark County.

We are also partnering with the Bureau of Land Management, Federal Highways, and the Nevada Department of Transportation to develop Red Rock Legacy Trail, a two-way multi-use trail through Red Rock Canyon National Conservation Area. This trail will allow locals and tourists of every skill level or recreational usage (biking, walking, running, etc.) the opportunity to enjoy a safe, easy-to-follow trail without the danger of automobile traffic.

We also had a lot of victories for pockets of District F, such as adding new medians, a crosswalk, and signage to ensure safety for parents, kids, and school staff at Stuckey Elementary and announcing to the Southern Terrace community additional streetlights, flood channel upgrades, and additional crosswalks. These improvements will ensure District F stays a place for families and businesses to prosper.







# **Giving Back**

Hosted the largest land cleanup on public lands day at Desert Breeze Park alongside community organizations.

Over 15,000 constituents attended events hosted by our office.

13,450 pounds of fresh food distributed to District F families.

157 dogs and cats were vaccinated and received other veterinary services at our Pet Fest event in Sandy Valley.

Funded \$45.6M for broadband infrastructure and to address deficiencies across Clark County.

Allocated \$30M to advance our water infrastructure, including a Southern Nevada Water Authority Septic System Conversion Pilot Program to connect septic system users to our sewer system, and a Cooling Tower Conversion Program to help businesses convert from swamp coolers to HVAC units.

Hosted the largest School Resource Fair in Clark County at Desert Breeze Community Center with over 4,000 attendees from across the valley.

Teamed up with organizations to plant drought-resistant trees at Desert Breeze Park to combat the heat island effect.
