SCOPE OF WORK: The Work consists of the construction of CMU and wooden waiting bench with handcuff rails, additional CMU and ballistic glass wall with transaction station and structural supports, added electrical and data outlets, and solid surface countertops, and new ballistic laminated glazing application at the exterior, storefront.

ESTIMATED COST: \$359,197.85 - \$378,103.00.
