SCOPE OF WORK: The Work consists of the demolition of all restroom fixtures, sinks, counters, stall partitions, lighting, floor drains & piping and all tile at floor and walls including entryways outside of restrooms. Haul away and dispose of all debris. Remove lockers and combo drinking fountain/bottle fillers, clean and store for re-installation. Work includes concrete cutting and patching at floor drains. Provide and install all new fixtures (sinks, urinals & toilets) and appurtenances, floor drains and associated piping, new tile at floors & walls, new stall partitions, counters, paint, paper towel & soap dispensers, hand dryers and LED lighting. Replace doors at North Men's restrooms and provide & install new door hardware.

ESTIMATED COST: \$323,000 - \$340,000.
