SCOPE OF WORK: The work to be performed is for the construction necessary for widening of the CC 215 West Bruce Woodbury Beltway from Charleston Boulevard to Far Hills Drive including removal of existing improvements; mainline concrete paving milling/grinding, UTACS, and concrete paving repairs; plantmix bituminous surfacing; bridge structures; drainage facilities; guardrail; concrete barrier rail; signage; lighting/luminaire replacement; milling; pavement markings; chain-link fence and gate; MSE walls, retaining wall, and soil nail wall; and traffic signal modifications.

ESTIMATED COST: \$76,224,778 - \$84,248,438.
