SCOPE OF WORK: The work to be performed is for the construction necessary for the installation of median fencing along Boulder Highway from Desert Inn Road to Flamingo Road including installing a 72-inch chain-link fence, including posts, double bracing, footings, grounding, retro-reflective sheeting, and permanent "No Pedestrian Crossing" signs mounted to the fence. The work also consists of traffic control, dust control, quality control, and other related items of work as specified and shown on the drawings.

ESTIMATED COST: \$1,513,160 - \$1,672,440.
