**SCOPE OF WORK:** The Work consists of the removal of existing steel tube fencing between existing CMU columns, repair of existing CMU columns, removal and restorations of existing irrigation, removal and replacement of damaged mow curb, new mow curb, new concrete, new precast bumper blocks, installation of 8 f.t. tall fencing and vehicular and pedestrian gates and installation of decomposed granite as indicated on these plans.
