SCOPE OF WORK: The work to be performed under this Contract is for Sunset Road Phase I, project limits is from Durango Drive to Decatur Boulevard. The improvements include asphalt pavement widening to provide minimum two travel lanes in each direction, center left-turn lanes, signage and striping, utility adjustments and relocations, and other appurtenances as may be necessary to construct a complete and functional roadway.
