NOTE: Clark County is soliciting and intends to award this Contract as a Nevada Prevailing Wage Public Works Project. All bidders shall prepare and submit their bids using the applicable Nevada prevailing wage rates for all labor classifications, regardless of the amount of the bidder's submitted bid.

SCOPE OF WORK: The Work to be performed under this Contract is for The Las Vegas Wash and Flamingo Wash Maintenance Access Improvements project. This project encompasses the installation of a drainage pad, access roads and other related work, grate replacement, and a hinged grate. This project is located SE of the intersection of Charleston Blvd and Nellis Blvd (+/-1100 ft South), East of the intersection of Nellis Blvd and Sahara Ave (approximately 600 ft South), and approximately 1400 East of the intersection of Sahara Ave and Sloan Blvd.

ESTIMATED COST: \$287,185 - \$317,415.
