NOTE: Clark County is soliciting and intends to award this Contract as a Nevada Prevailing Wage Public Works Project. All bidders shall prepare and submit their bids using the applicable Nevada prevailing wage rates for all labor classifications, regardless of the amount of the bidder's submitted bid.

SCOPE OF WORK: The work consists of the construction of approximately 650 sf of storage expansion to room 130 to accommodate Recreation Center needs. Storage expansion to match existing building's CMU including color and metal materials and connect to the existing fire sprinkler and lighting control systems. The two existing storage containers will be relocated onto a concrete pad.

ESTIMATED COST: \$366,567 - \$385,860.
