CCC10.08.135(a) No person shall cause or allow any dog one year of age or older or cat eight months of age or older owned, harbored or kept to breed unless the person has obtained a breeder permit. (b) To initiate a breeder/show permit, a permit fee shall be paid to Clark County Animal Protection Services ("CCAPS") at a cost of \$800 and shall be renewed annually for \$800 or \$400 when each animal has participated once per year in a show as defined in section 10.04.275. The permit fee includes initial site inspection by CCAPS. The owner must pass the inspection prior to the permit being issued or renewed. (c) If owner fails site inspection or is found in violation of this chapter, CCAPS will perform a re-inspection to ensure compliance, the breeder shall pay a re-inspection fee of \$100. If the owner fails re-inspection, the permit shall be denied. **\*\*\*BREEDING AND/OR SELLING ON THIS PERMIT IS NOT ALLOWED\*\*\***

All permits are subject to a mandatory inspection. Permit fee is \$400 for animals that are shown and \$800 for animals not shown. If applicant fails the first inspection, the applicant will be charged a \$100 re-inspection fee. A permit may be revoked should the permit holder be found in violation of CCC 10.32 or CCC 10.08.135. **\*\*\*Applications without supporting documents will not be approved. Permits must be renewed each year. Non-compliance of CCC Title10 may result in prosecution.** By signing below, I agree to all provisions of CCC Title 10 and understand that if any violations occur, this permit is subject to possible revocation, non-renewal and/or prosecution. **\*\*\*County Business License Required if Selling Dogs or Cats\*\*\***
