Receive a report from Clark County Administrative Services regarding updates from Clark County (for discussion only) Meggan reported that the street lights have been replaced around town, ET-20-400050 (UC-18-0124) was approved by the Planning Commission, the pot holes at the intersection of Las Vegas Blvd. and SR 161 in Jean have been repaired, an agreement between BLM and the County has been signed to allow the improvements to Sandy Valley Road, Family Dollar store has been approved for Sandy Valley, and it is time to submit applications for the next CAC term.
