A. Draft Fiscal Year 2027 Predation Management Plan (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss and make recommendations to the Nevada Board of Wildlife Commissioners about the draft fiscal year 2027 Predation Management Plan. Following this review, the draft plan will be updated and shared with the (PARC) State Predatory Animal and Rodent Committee. All comments from the PARC, and (CCABMW) County Advisory Board to Manage Wildlife and any other interested entity will be compiled and shared with the (WDMC) Wildlife Damage Management Committee for their consideration at their March 2026 meeting.

B. Commission General Regulation 529-Disability Permit Program Revision (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about language regulation amending Nevada Administrative Code (NAC) that would update business rules and requirements related to the archery, visual and special assistance disability permits.

C. Commission Regulation 25-07 Amendment #2, 2025-2026 and 2026-2027 Big Game Seasons (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting an amendment to the 2026-2027 hunting seasons and dates for mule deer, pronghorn antelope, elk, bighorn sheep, mountain goat and moose, including limits, hunting hours, special hunt eligibility, animal sex, physical characteristics, hunt boundary restrictions.

D. Commission Regulation 26-01, 2027 Spring Turkey and 2026 Application Deadlines (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2027 spring turkey application deadlines and 2026 tag application deadlines and related information.

E. Commission Regulation 26-02, 2026 Tag Application Eligibility and Tag Limits (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2026 tag application eligibility, tag limits and related information.

F. Commission Regulation 26-03, 2026 Dream Tag Seasons and Quotas (*For possible action*). The Clark County Advisory Board to Manage Wildlife Board will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about a regulation to set the 2026 dream tag species, seasons, and quota.

G. Commission Regulation 26-04, 2027 Heritage Tag Seasons and Quotas (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2027 Heritage tag species, seasons, and quota.

H. Commission Regulation 26-05, 2026 Partnership in Wildlife Tag Seasons and Quotas (For possible action). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2026 Big Game Silver State Tag and 2027 Wild Turkey Silver State Tag species, seasons, and quota.

I. Commission Regulation 26-06, 2026 Big Game Silver State and 2027 Wild Turkey Silver State Tag Seasons and Quotas (For possible action). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2026 dream tag species, seasons, and quota.

J. Commission Regulation 26-07, 2026 Black Bear Seasons (For possible action). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2026 hunting season dates, open management units, hunting hours, special regulations, animal sex, legal weapon requirements, hunt boundary restrictions, and dates and times for indoctrination courses for black bear.

K. Commission Regulation 26-08, 2026-2027 Mountain Lion Season and Harvest Limits (For possible action). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2026-2027 hunting season open units, harvest limits by unit group, hunting hours and special regulations for mountain lions.

L. Commission Regulation 26-09, 2026-2027 Restricted Non-Resident Guided Mule Deer Seasons and Quotas (For possible action). The Clark County Advisory Board to Manage Wildlife will review, discuss and make recommendations to the Nevada Board of Wildlife Commissioners about adopting a regulation to set the 2026-2027 hunting season and quotas for restricted non-resident guided mule deer including hunt boundary restrictions.
