- a. Petition- Mr. Cody Knight (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about Mr. Knight's petition to the Nevada Board of Wildlife Commissioners for a hound hunting permit to be implemented in Nevada for hunting with dogs for mountain lion, bobcat, and black bear.
 - Vice Chair Dan Gilbert advises the motion to refuse petition as submitted.
 - Board Member Dave Talga seconds the motion.
 - Motion passes 6-1 (dissenting opinion: board member in favor and does not have issue with charging non-resident hunters extra)
- b. Fiscal Year 2025 Predation Management Plan: Amendment #1 (For possible action). The Clark County Advisory Board to Manage Wildlife will discuss and make recommendations to the Nevada Board of Wildlife Commissioners about an amendment to the Fiscal Year 2025 Predation Management Plan to alter funding distribution between existing projects.
 - Board Member John Hiatt advises motion for approval of the FY 2025 Predation Management Plan: Amendment #1 as presented.
 - Board Member Alexander Harper seconds the motion.
 - Motion passes 7-0.
- c. Fiscal Year 2026 Predation Management Plan (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss and make recommendations to the Nevada Board of Wildlife Commissioners about the final draft of the Fiscal Year 2026 Draft Predation Management Plan.

- Board Member John Hiatt advises motion for approval of the FY 2026 Predation Management Plan as presented.
- Board Member Annoula Wylderich seconds the motion.
- Motion passes 7-0
- d. Discussion on Coyote Hunting Contest Regulations (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss and make recommendations to the Nevada Board of Wildlife Commissioners about draft coyote hunting contest regulations and potential regulatory provisions for coyote calling contests. These may include, but are not limited to, licensing requirements for participation in the contests, licensing for hunting all species (both unprotected and protected) and the establishment of coyote calling contest season September 1 through March 31).
 - Chair Paul Dixon advised that this is hereby rejected based on the CABs previous two recommendations in which they were not in favor and advised it should be a county-to-county basis, following the same practices as trapping.
 - Chair Paul Dixon advised that this requires placement of rules and regulations on a non-protected species.
 - Board Member Annoula Wylderich asked Chair Paul Dixon if the counties that are in favor of this be regulated.
 - Chair Paul Dixon advised that it would be a hybrid solution.
 - Vice Chair Dan Gilbert advised that there should be license requirement or hybrid recommendation.
 - Public Comments: (Bob Bobbett- fishing contests are not regulated by NDOW then why would the coyote contest be regulated. He stated he felt it should be regulated by the Gaming Commission.
 - Board Member John Hiatt seconds the motion.
 - Motion passes 7-0.
- e. Legislative Committee Report (*For possible action*). Commission Regulation 25-12, 2025 Black Bear Quotas and Harvest Limits (*For possible action*) The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about the 2025 hunting season and quotas and harvest limits for black bears.
 - Chair Paul Dixon introduced this topic.
 - Vice Chair Dan Gilbert advised motion for approval for CR 25-12, 2025 Black Bear Quotas and Harvest Limits
 - Board Member Dave Talaga seconds the motion.
 - Motion passes 6-1 (dissenting opinion based on concerns with climate changes that affect black bears).
- h. Commission Regulation 25-07, Amendment #1 2025-2026 and 2026-2027 Big Game Seasons (*For possible action*). The Clark County Advisory Board to Manage Wildlife will review, discuss, and make recommendations to the Nevada Board of Wildlife Commissioners about Commission Regulation 25-07 Amendment #1 2025-2026 and 2026-2027 Big Game Seasons.

 - Public Comments: (*Pat Cummings, member of the public*): He advised there needs to be clarification to the muddy to let the Valley State Park Workers know regulation changes.
 - Chair Paul Dixon advised this item is hereby closed.
