NOV #10307 – Formal Withdrawal of Appeal and Acceptance of Penalty

Good morning,

Yesterday, I conferred with counsel for both appellants regarding resolution of the pending appeal and the allocation of the \$4,000 administrative penalty. This email is to formally document the resolution of the appeal arising from Notice of Violation No. 10307, issued jointly to Lanz Construction LLC and Bulmaro Cruz.

On Tuesday, August 4, 2026, at 5:08 p.m., Logan G. Willson, counsel for Lanz Construction LLC, confirmed in writing that Lanz Construction LLC withdraws its appeal, accepts the administrative penalty assessed under NOV #10307, and agrees to pay \$2,000 toward the total penalty.

On Tuesday, August 4, 2026, at 8:14 p.m., Paul Ray, counsel for Bulmaro Cruz, confirmed in writing that Mr. Cruz likewise withdraws his appeal, accepts the administrative penalty assessed under NOV #10307, and agrees to pay the remaining \$2,000.

Accordingly:

- Both appellants have formally withdrawn their appeal of NOV #10307;
- Both appellants have accepted the Hearing Officer's assessment of the \$4,000 administrative penalty;
- Lanz Construction LLC has agreed to pay \$2,000;
- Bulmaro Cruz has agreed to pay \$2,000; and
- The two payments, once received, will collectively satisfy the full \$4,000 penalty.

Separate invoices in the amount of \$2,000 have been issued to each appellant. The separate invoices reflect the parties' agreed allocation of payment and do not alter the total amount of the administrative penalty assessed under NOV #10307.

Because the appeal has been withdrawn by both appellants, no contested evidentiary hearing is necessary. Please update the Department's records to reflect the withdrawal

and agreed payment arrangement. For purposes of today's Hearing Board meeting, the matter may be identified on the record as withdrawn and resolved pending receipt of the full \$4,000 payment, subject to any procedural direction from Hearing Board Counsel or the Chair.

I have already forwarded the written confirmations from counsel for inclusion in the administrative record.

3. The Hearing Officer finds that the violation(s) alleged in NOV #10307 occurred in that LANZ CONSTRUCTION and CRUZ violated AQR Sections 94.13(a) and (b) on April 3, 6, and 7, 2026.

4. **IT IS HEREBY ORDERED** that LANZ CONSTRUCTION and CRUZ pay a penalty of Four Thousand and no/100 Dollars (\$4,000.00) within 30 days of the date of this ORDER.

5. LANTZ CONSTRUCTION and CRUZ have the right to appeal this ORDER to the Clark County Air Pollution Control Hearing Board. Any appeal of this ORDER shall be: (1) on a form provided by Air Quality specifying the reason(s) for the appeal, (2) accompanied by a filing fee of One Hundred Forty and no/100 Dollars (\$140.00), and (3) received by Air Quality within ten (10) days of LANTZ CONSTRUCTION and CRUZ's receipt of this ORDER.

To Whom It May Concern:

Lanz Construction LLC respectfully submits this written response contesting Notice of Violation #10307. After reviewing the circumstances surrounding the April 3–7, 2026 inspections, Lanz Construction asserts that the activities observed by Air Quality personnel were **not initiated, directed, supervised, or authorized by Lanz Construction** at any time during the referenced period.

Our internal review confirms that the soil-moving activity was **initiated solely by property owner Bulmaro Cruz**, who independently arranged for a **third-party trucking contractor** to remove and relocate soil to his personal lot. These exporting and loading operations were **not contracted through Lanz Construction**, and the company had **no prior knowledge** that Mr. Cruz had instructed a third-party hauler to begin work on the parcel.

Although Lanz Construction personnel were present on the property under the belief that a legitimate contract existed, **no employee or subcontractor under our control was performing soil-disturbing activity** during the times cited in the NOV. Equipment and operators were made available based on representations made by Mr. Cruz, which we later learned did not reflect an authorized or permitted project.

When our project manager, Nick Pressimone, was contacted by Air Quality on April 3, he was **unaware that Mr. Cruz had independently initiated exporting activity**. Upon receiving this information, Mr. Pressimone immediately advised Mr. Cruz that a Dust Control Operating Permit (DCOP) was required and that **all activity must cease immediately** until proper compliance measures were in place.

The unstable soil conditions observed on April 3, 6, and 7 were the direct result of **unauthorized third-party operations** occurring outside of Lanz Construction's control. Lanz

Construction did not direct the work, did not authorize soil disturbance, and did not supervise the third-party trucking contractor hired by Mr. Cruz.

Once Mr. Cruz submitted the DCOP application, Lanz Construction—still operating under the belief that the project would be formalized properly—cooperated fully with Air Quality to ensure the site was stabilized. Compliance was confirmed during the April 8 inspection.

Please note that on April 30th, 2026 we received a letter of notification by email. With this following information.

NOTICE OF VIOLATION #10307

Clark County Department of Environment and Sustainability, Division of Air Quality (**Air Quality**) provides this notice to Lanz Construction LLC (**Lanz Construction**), and Bulmaro Cruz (**Cruz**), individually, for the violation of the Clark County Air Quality Regulations (**AQRs**) as alleged below and recommends a civil penalty of Four Thousand and no/100 Dollars (\$4,000.00) be assessed as shown in the penalty calculation table attached hereto as **Exhibit A** and incorporated herein.

I. FACTS

- A. Air Quality Specialist Mike Englehart (**Englehart**), Senior Air Quality Specialist Andrew Kirk (**Kirk**), and Air Quality Specialist Marc Miller (**Miller**) discovered the alleged violations while performing a complaint investigation during a Construction Notice period on April 3, 2026, and follow-up inspections on April 6 and 7, 2026, at the Dirt Removal construction project

(Assessor's Parcel Number 125-24-304-007), located at 5521 Ano Drive, in Clark County, Nevada.

- B. On Thursday, April 2, 2026, at approximately 9:11 a.m., Air Quality issued a Construction Notice to all Dust Control Operating Permit Holders, Contractors, and Stationary Sources informing them the National Weather Service and weather models used by Air Quality forecast sustained winds of 20 mph, with gusts over 30 mph, for Friday, April 3, 2026, beginning at 8:00 a.m. and lasting through 4:00 p.m. Air Quality directed all permittees to inspect their site(s) and employ Best Available Control Measures to stabilize all disturbed soils. The Construction Notice is attached hereto as **Exhibit B** and incorporated herein.
- C. On Friday, April 3, 2026, at approximately 8:26 a.m., Air Quality received a complaint (#77903) alleging a side dump truck and bulldozer was loading and hauling out loads of dirt and dirt was blowing everywhere at 5521 Ano Drive, a vacant lot. The complaint report is attached hereto as **Exhibit C** and incorporated herein. At approximately 9:15 a.m., on the same day, Englehart arrived at the Dirt Removal construction project to investigate the complaint. The inspection report is attached hereto as **Exhibit D** and incorporated herein. Englehart assigned construction project #60205 to the inspection for tracking purposes. During the investigation, Englehart observed a wheel loader loading soil into a haul truck for export from 5521 Ano Drive. The vacant parcel contained multiple soil stockpiles, approximately 0.75 acres of dry, loose, and powdery site soil conditions and greater than 0.25 acres of construction activities occurring without a Dust Control Operating Permit (**DCOP**) as shown in Photographs 1 and 2, and Map 1, attached hereto as **Exhibits E and F**, respectively, and incorporated herein. While onsite, Englehart spoke by phone with Nick Pressimone (**Pressimone**), Project Manager for Lanz Construction, concerning his observations of noncompliance and the issuance of a Notice of Noncompliance (**NON**). The NON was emailed to Pressimone and is attached hereto as **Exhibit G** and incorporated herein. Englehart also observed that the noncompliance issue occurred within 1,000 feet of a residential area, as shown in Map 2, attached hereto as **Exhibit H** and incorporated herein. Englehart concluded his inspection at approximately 10:15 a.m.

At 10:45 a.m., on the same day, Belen Cruz (**B. Cruz**), daughter of Cruz, submitted a DCOP application #28694 to Air Quality for 1.0 acre of the unpermitted area. During the review process, B. Cruz updated the permitted area to 1.2 acres.

- D. On Monday, April 6, 2026, at approximately 2:05 p.m., Kirk arrived at the Dirt Removal construction project to conduct a follow-up inspection. The inspection report is attached hereto as **Exhibit I** and incorporated herein. During the inspection, Kirk observed approximately 0.75 acres of dry, loose, and powdery site soil conditions, as shown in Photographs 3 through 7 (**Exh. E**). Kirk noted that Lanz Construction notified Cruz that he needed to apply for a DCOP since an application had been submitted after the first inspection. While onsite, Kirk left a phone message with Cruz, and spoke by phone with B. Cruz, concerning his observations of noncompliance. Kirk also observed that the noncompliance issue occurred within 1,000 feet of a residential area, as shown in Map 3, attached hereto as **Exhibit J** and incorporated herein. Kirk concluded his inspection at approximately 2:25 p.m.

- E. On Tuesday, April 7, 2026, at approximately 11:18 a.m., Kirk sent an email to Cruz regarding the construction activities occurring on the site and the conversation with B. Cruz concerning the NON issued on Friday, April 3, 2026. Kirk stated that based on the aerial map of the site (**Exh. F**), exporting activities were occurring for a while, and a DCOP was required to continue. Kirk also stated that the site soils must be stable 24 hours a day, 7 days a week. The email correspondence is attached hereto as **Exhibit K** and incorporated herein.

At approximately 12:00 p.m., on the same day, Miller arrived at the Dirt Removal construction project to conduct a follow-up inspection. The inspection report is attached hereto as **Exhibit L** and incorporated herein. During the inspection, Miller observed approximately 0.75 acres of dry, loose, and powdery site soil conditions, as shown in Photographs 8 through 10 (**Exh. E**). Miller observed no exporting activities, but there were stockpiles onsite and a loader located on the western end of the site. While onsite, Miller left a phone message with Cruz, concerning his observations of continued noncompliance. Miller also observed that the noncompliance issue occurred within 1,000 feet of a residential area, as shown in Map 4, attached hereto as **Exhibit M** and incorporated herein. Miller concluded his inspection at approximately 12:15 p.m.

- F. On Wednesday, April 8, 2026, at approximately 10:00 a.m., Miller arrived at the Dirt Removal construction site to conduct a follow-up inspection. The inspection report is attached hereto as **Exhibit N** and incorporated herein. During the inspection, Miller observed the site was in compliance with AQRs. Miller concluded the inspection at approximately 10:15 a.m.
- G. On Tuesday, April 14, 2026, the application was approved by Air Quality, and an invoice was issued to Cruz for the fees associated with the DCOP. Cruz submitted payment for the DCOP on Friday, April 17, 2026, at which time DCOP #60205 was issued.

II. VIOLATION(S)

Violation 1:

By failing to employ Best Available Control Measures (**BACM**) and comply with soil stabilization standards 24 hours a day, seven days a week, Lanz Construction and Cruz violated AQR Sections 94.13(a) and (b).

AQR Sections 94.13(a) and (b) state:

- “(a) Any person who engages in a construction activity or temporary commercial activity with or without a DCOP that causes or may cause fugitive dust emissions, shall employ BACM and comply with the soil stabilization standards in Section 94.12 and emissions standards in Section 94.14.
- (b) Control measures in a DCOP, and other measures as needed for the purpose of maintaining dust control, shall be implemented 24 hours a day, 7 days a week, until the DCOP is closed in accordance with Section 94.5(o)(2).”

III. RECOMMENDED CIVIL PENALTY

Pursuant to AQR Section 9.1, any person who violates any provision of the AQRs, including any permit condition; is guilty of a civil offense and shall pay a civil penalty not to exceed \$10,000 per violation. Each day of violation constitutes a separate offense.

Air Quality considered the following in calculating the recommended penalty:

- Violation occurred during a Construction Notice period (**Exh. B**); and
- Violation occurred within 1,000 feet of the outer boundary of a residential area as described in Paragraphs I.C, I.D and I.E above (**Exhibits H, J and M**).

Air Quality recommends a civil penalty in the amount of \$4,000.00 (**Exh. A**).

IV. HEARING

Air Quality has scheduled a hearing for **Thursday, May 21, 2026, at 9:00 a.m.** before the Air Pollution Control Hearing Officer to adjudicate the alleged violation(s) and, if appropriate, to levy the recommended penalty. Please complete the enclosed **“Notice of Violation Response Form”** and return it to Air Quality by May 7, 2026. At the hearing, the Hearing Officer will hear evidence on the alleged violation(s) and render a decision. The hearing will be held at the Clark County Building Services Presentation Room, located at 4701 West Russell Road, Las Vegas, Nevada.

If you intend to present any documentary evidence at the hearing, please provide copies of your evidence to Air Quality with the completed Notice of Violation Response Form. If you fail to provide copies of your evidence prior to the hearing, please be advised that Air Quality may request a continuance to have time to review any evidence you bring to the hearing, which will result in the hearing being postponed and rescheduled to a later date.

If the Hearing Officer finds you in violation and levies a penalty, Air Quality staff will mail the Hearing Officer’s order to you along with instructions on remittance of the penalty.

I conducted a dust complaint investigation during a Construction Notice period and observed a wheel loader loading soil into a haul truck for soil export at 5521 Ano Drive. The vacant parcel contains multiple soil stockpiles and the soil disturbance is greater than 1/4 acre, requiring a dust permit. The soil was observed to be dry, powdery, and unstable and when haul trucks drove through these soils, fugitive dust was emitted. No water source in use onsite now, or since start of work this morning. No trackout control device is onsite. I met onsite with the loader operator, who put me in contact with his Supervisor, Nick Pressimone, with Lanz Construction LLC. I informed Mr. Pressimone about the complaint and asked if he had applied for a dust permit. He had not. I issued a Notice of Noncompliance with possible NOV, to immediately stabilize all site soils; submit an application for a DCOP to Air Quality by 4/4/26 and install a trackout control device by 4/7/26. Mr. Pressimone said he understood the NON with possible NOV and will stop all work immediately and get a water truck out to wet down the site ASAP.

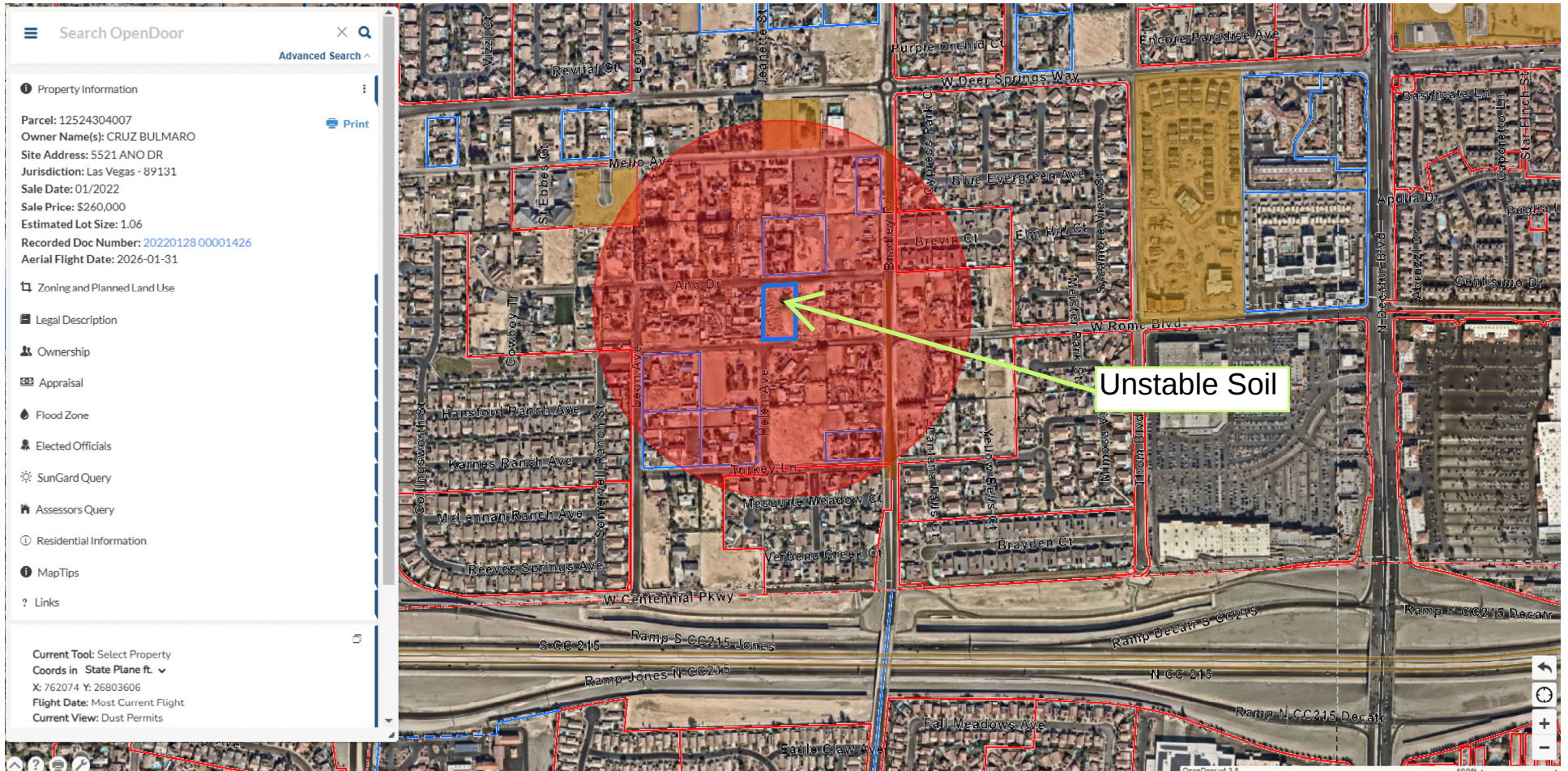

I conducted a follow-up inspection and observed approximately 0.75 acres of dry, loose, powdery soils. This follow-up inspection was completed based on a Notice of Non-Compliance (NON) that was sent to Lanz Construction on 4/3/2026, for exporting soil without a DCOP causing unstable site soils. Apparently, after Lanz Construction received the NON, they called the property owner, Mr. Bulmaro Cruz, and told him that he needed to get a dust permit and stabilize the site soils; the application was submitted on 4/3/2026 by the property owner. After my follow-up inspection today, I left a message for Mr. Cruz and about 5 minutes later, his daughter, Ms. Belen Cruz called me so I discussed the non-compliance issues and told her that she needed to stabilize site soils immediately and keep them moist or crusted 24/7, install a dust sign by close of business 4/14/2026, sign up for a dust class (or hire someone that has certification), and install a trackout control device by 4/8/2026. Ms. Cruz stated that she didn't know how to get a water source out to the property, get a dust sign made, or what a trackout control device was so I recommended that she call Lanz Construction to have them help stabilize the soils and explain everything because they know our Regulations since they do construction in Las Vegas and deal with Air Quality on a regular basis. I once again made it very clear that the first step was to get all of the soils stabilized immediately and she then went on to explain that they only needed to export a small amount of soil and nothing more would be done for about a year. I let her know that if this was the case, then she would need to block access to her property after stabilizing the soils to avoid any illegal dumping that might occur over the next year while the project was on hold. I let her know							

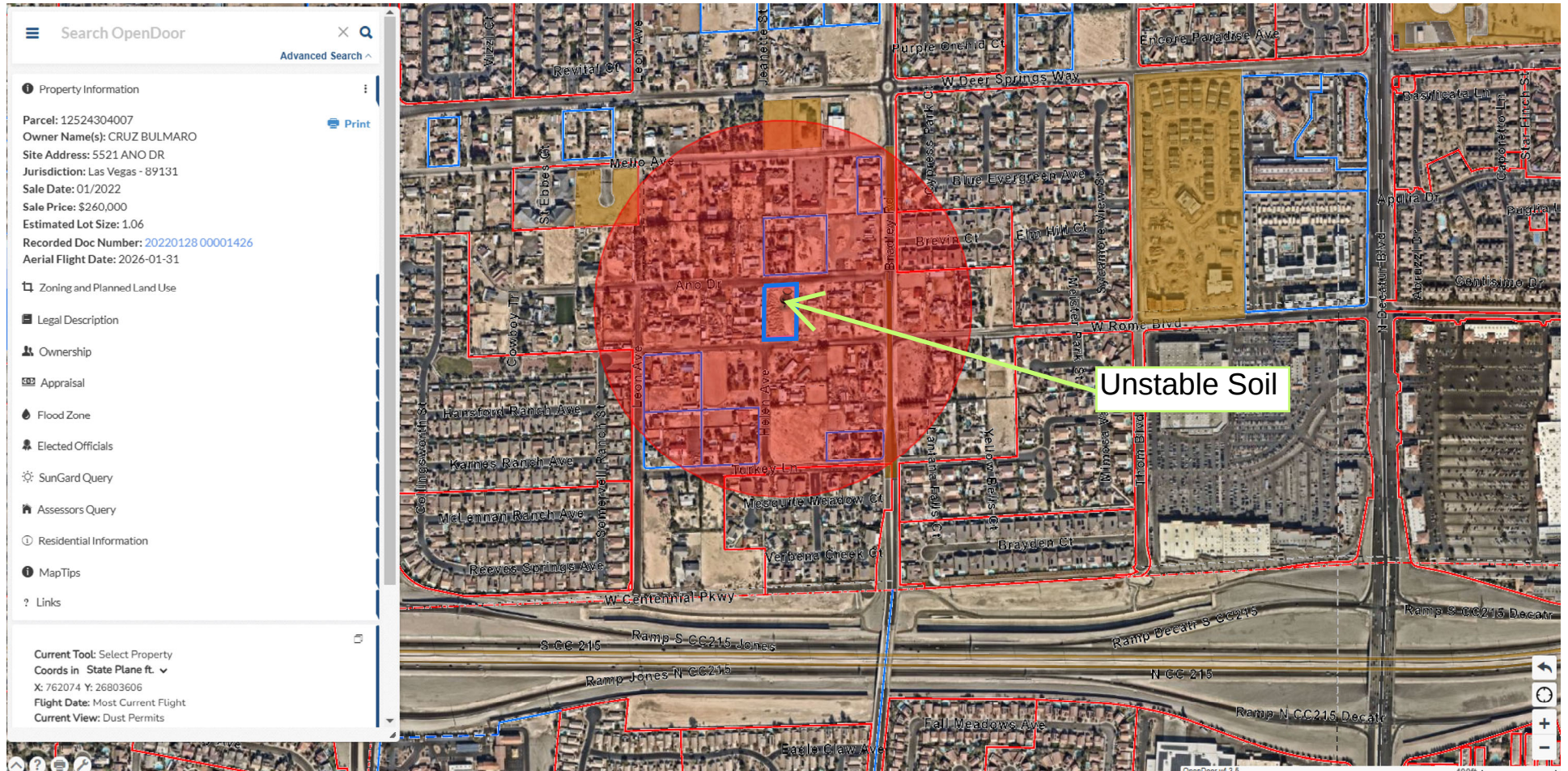

that she still needs to take the dust class or hire someone with a certification and install a dust control sign but could wait until next year to install a trackout control device since she will be blocking access. Ms. Cruz stated that she understood what I had explained to her and would make sure to relay all of this information to her father. I once again made it very clear that the soils need to be stabilized right away because we will be completing follow-ups every day until the site is back into compliance.

Good morning Mr. Cruz,

My name is Andrew Kirk, and I work for Clark County Air Quality. I'm writing this e-mail to you in regard to the construction activities that are occurring at your property, 5221 Ano drive, and the conversation that I had with your daughter yesterday. I was letting her know what had happened last week, when another one of our inspectors, Mike Englehart, was following up on a complaint regarding fugitive dust on your property and saw Lanz Construction exporting soils without a Dust Control Operating Permit (DCOP), causing unstable soils. Mr. Englehart issued a Notice of Non-Compliance (NON) to Lanz Construction on Friday, 4/3/2026 and I guess they called you and told you that you needed a DCOP. Your daughter applied for one already but there are things that need to be fixed before it can be approved, so check your e-mails for communication from us.

Furthermore, some of the information that your daughter gave me yesterday was not accurate (I know she is not involved with this work and might not know what is going on) so I just need for you to explain what you are doing. I was told that work was complete and you would not be touching the property again for at least a year when you will be building a home. I was also told that this was a 1-day activity but based on my aerial photo review of your property, there has been exporting occurring before last Friday (see aerial photo below), which also needed a DCOP to do. This aerial was taken on 1/31/2026 and there are stockpiles all over your site. Based on the number of stockpiles (way less) I saw yesterday,

you have been exporting soil for a while. I also saw a loader on-site, which tells me that additional work will be completed, which is ok once the DCOP is approved and has been given to you, but soil stabilization is required 24/7.

I wanted to let you know so that you are fully aware that anytime that you disturb soils, whether it's to build something or to import/export soil, a DCOP is required and soils must be kept stable so that fugitive dust does not occur. It appears that there is more exporting that needs to be done before you halt activities for a year to build your home. Once your DCOP is approved, you will get a copy by e-mail, and at that time you will be able to continue construction activities. The NON that was sent to Lanz Construction on Friday has been included in this e-mail for you to review. As the DCOP holder, you are responsible to adhere to everything listed within this NON. You will need to have someone attend a dust class, install a dust control sign, keep the soils stable 24/7, install a trackout control device, and implement BMP-11 Long-Term Stabilization on your property if your construction activities cease for more than 30 days. This means that you will need to block access to your property so that during your down time (a year until you build), other companies do not illegally dump on your site. I recommended to your daughter that you use some of the soil on-site to build a minimum 4-foot berm around the north and south sides (with no trespassing signs) to prevent access and make sure all soils are stable after installation. I want to make it clear that anything that happens to your property while under this DCOP, is your responsibility and that is exactly why we require it to be blocked off so that people are not disturbing the soil without your knowledge. If you change your mind and decide to build right now, you are obviously free to do so once that DCOP has been approved and given to you. Please ensure that all soils are stabilized immediately and maintained 24/7. The soils on your property most likely do not absorb water very well (based on other sites we patrol in your area), so every time you drive on it, the soils will become dry, loose, and powdery and you will need to stabilize it.

Please explain your plans and that you understand what is required. The trackout control device needs to be installed by close of business 4/8/2026 and the dust sign needs to be installed by close of business 4/14/2026. Once all construction activities are complete and no additional work will be done, you will have 30 days in block access to your site and install the signs to cover you until you start work again. Please do not forget to renew your DCOP before it expires next year if you still plan and developing it. If you have any questions feel free to call myself or the inspector for your area, Mike Englehart at (702) 249-8594. Thank you,

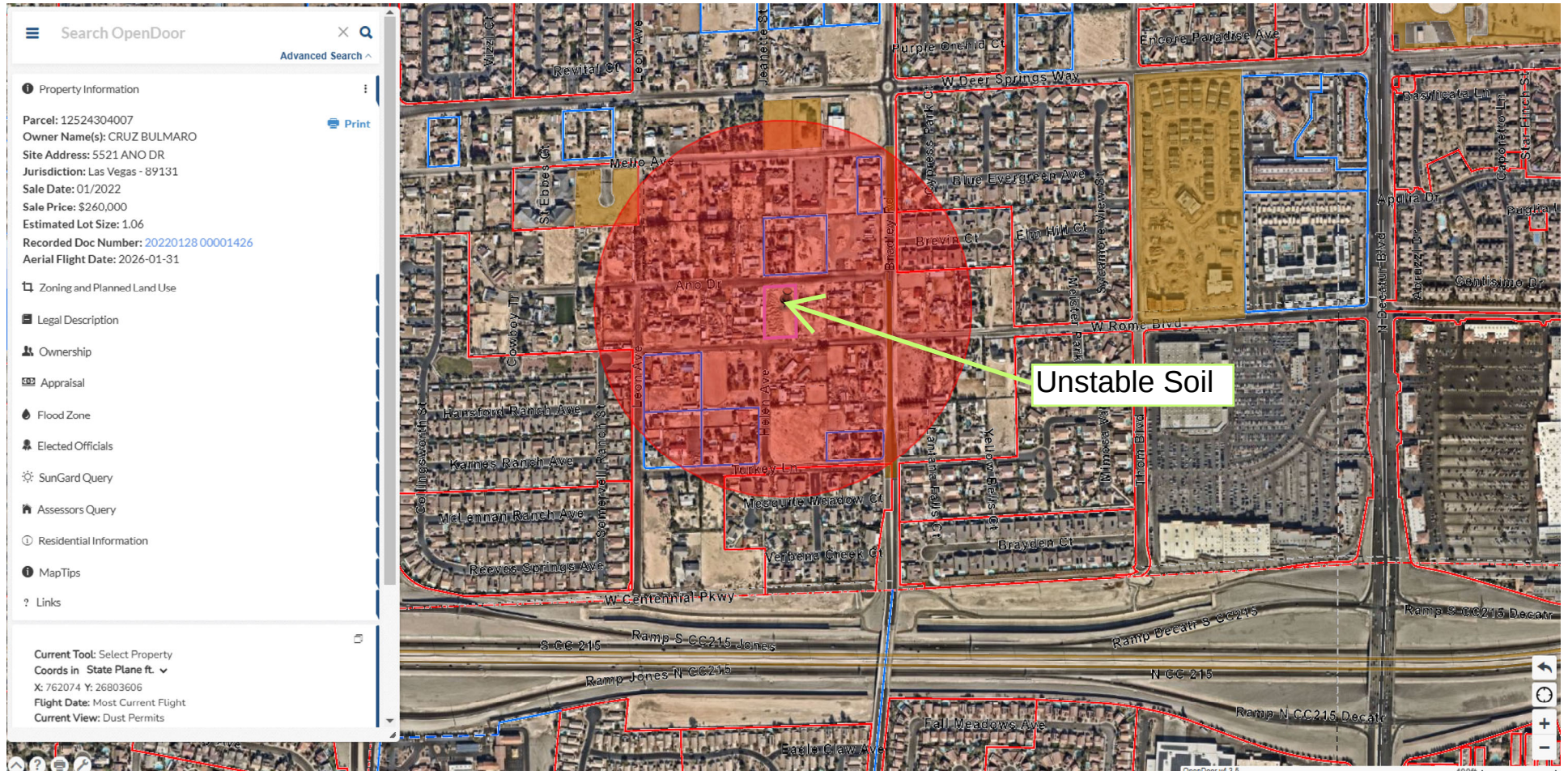

• 1997 O₃ NAAQS- attainment/maintenance:

- 2nd 10-year maintenance plan was approved by EPA in April 2024.

• 2015 O₃ NAAQS:

- Since April 15, 2025, DAQ has worked closely with consultants to develop the 2015 Ozone National Ambient Air Quality Standards (NAAQS) Serious Attainment Plan.
- The plan underwent the full public participation process, including a public hearing on July 7, 2026, at which the Board of County Commissioners (BCC) adopted the plan and approved its submittal to the Nevada Division of Environmental Protection (NDEP).
- All SIP elements have been transmitted to NDEP for incorporation into the State Implementation Plan package. NDEP is expected to submit the package to EPA in early August 2026.
- SIP development included several regulatory actions, including new emission controls for coating operations, revised permitting requirements, additional Reasonably Available Control Technology (RACT) requirements for major stationary sources, and a contingency measure to reduce emissions from emulsified asphalt operations if the area fails to attain the standard by the statutory deadline.
- The SIP also includes a Clean Air Act Section 179B demonstration showing that international emissions could prevent Clark County from attaining the ozone standard by the statutory deadline. This demonstration serves as a contingency to the primary attainment demonstration should EPA not concur with the treatment of wildfire emissions as exceptional events.
- Information on the plan's development, including workshops, rulemakings, public notices, and supporting documents, is available on the [Ozone Serious Attainment Plan](#) webpage.

- **PM₁₀- attainment/maintenance**
 - The Second PM₁₀ Ten-Year Maintenance Plan is currently undergoing final review by the EPA. The plan demonstrates that DES will continue to maintain compliance with the PM₁₀ National Ambient Air Quality Standards through 2034.
- **PM_{2.5}- attainment**
 - DES is currently attaining the 2024 PM_{2.5} annual NAAQS. Recommendations were submitted to NDEP/EPA within the regulatory deadline and we're awaiting final designations.
- **Nitrogen dioxide (NO₂) – attainment**
- **Sulfur dioxide (SO₂) – attainment**
 - **Attainment** of the primary NAAQS.
 - Clark County is currently attaining the 2024 SO₂ secondary NAAQS. An SO₂ area designation letter was submitted to NDEP in September and was subsequently submitted to EPA on October 15, 2025. DAQ recommended a designation of “attainment” for Hydrographic Area 212 (the Las Vegas Valley) and “attainment/unclassifiable” for the remaining areas in Clark County. The associated Infrastructure SIP for the newly promulgated standard is due December 2027.
- **Lead (Pb) – attainment**
- **Studies**
 - The multi-year VOC smoke tracer study has continued, and sampling for 2026 has begun. The study supports anticipated exceptional events demonstrations and ozone SIP efforts.
 - The residential wood combustion and construction equipment emissions study has begun.
- **Modeling**
 - Increment Modeling: Approx. 14 major, 75 minor source reviews.
 - Photochemical modeling was completed to support the ozone SIP requirements for the 2015 NAAQS.
- **Smog Free Clark County**

Began in 2023, the Smog Free Clark County (SFCC) program is designed to improve air quality by reducing motor vehicle emissions. Owners of eligible vehicles from model years 1968 to 2006 may qualify for up to \$975 in emissions-related repairs. Beginning July 1, 2026, vehicles with model year 2010 or older are

eligible for participation into the program. Table 1 summarizes the vehicle repairs of this program through the end of FY '26.

➤ Monitoring

- Implemented 2026 Annual Monitoring Network Plan
 - Stations located in neighbourhoods to assess exposure levels to the general population (18 AQ stations).
 - Network characterized pollution transported into Clark County and background levels natural to Clark County.
 - Deployed Photochemical Assessment Monitoring Station (PAMS) to monitor ozone precursors (NO₂ and VOCs), carbonyls, mixing layer, and solar/UV radiation.
 - Conducted additional ozone monitoring at Apex, Spring Mountain Youth Camp (SMYC) and Indian Springs during ozone season (April 1st – September 30th).
 - Deployed trace CO monitor SMYC during ozone season (April 1st – September 30th).
 - Continues sampling for County-wide monitoring study of wildfire tracers including acetonitrile, VOCs, carbonyls, and L-glucosan (April 1st – September 30th).
- Completed 2027 ozone monitoring waiver and obtained EPA approval
 - EPA granted ozone monitoring exemption for Indian Springs and Apex in 2026 (off ozone season).
- Replacement of aging AQ monitoring stations continues under EPA 103 Inflation Reduction Act (IRA) Grant. The project managed by Real Property Management (RPM) began in July 2025 and remains on schedule.

- Hired new AQ Forecaster (July 2026) to support succession planning and ensure continuity of operations.
- Recruitment continues for AQ Monitoring Technicians to fill remaining vacancy and maintain staffing levels.
- Presented scientific poster at the Air & Waste Management Association (AWMA) National Conference in Austin, TX in June 2026.

➤ Stationary Source Permitting

- From January through June 2026, the department received 286 stationary source permit applications and issued 286 permits. This includes four renewals and two significant revisions of Title V operating permits. Of the total number of permits issued, 96.15% were completed within required regulatory timelines, exceeding the department's performance goal of 90%.
- As of June 30, 2026, there were 1,211 active stationary source operating permits, including 34 Title V operating permits.
- A total of 54 sources are currently registered across all CTG categories, the majority of which are Gasoline Dispensing Facilities (GDFs) with annual throughput below 120,000 gallons.
- Program Highlights (January through June 2026)
 - To proactively manage Title V operating permit renewals and prevent backlog, DES contracted local environmental consultant Broadbent & Associates. Under this three-year agreement, the firm will draft up to 10 renewal permits.
 - In response to recent revisions to Air Quality Regulation (AQR) Section 102: Gasoline Dispensing Facilities, DAQ updated its GDF minor source and general permits. Existing GDF general permit holders will receive their revised permit, along with their Authority to Operate (ATO), in the coming months.
 - DAQ started implementing AQR 122 control requirements in applicable Title V operating permits. AQR 122 establishes and implements Reasonably Available Control Technology (RACT) requirements for existing major stationary sources of nitrogen oxide (NO_x) and/or volatile organic compounds (VOCs) as required by Section 182(b)(2) of the Clean Air Act (Act).

➤ Compliance: Dust Permits and Vacant Land

- Issued 1,427 dust permits from January 1, 2026, through June 30, 2026; averaged 2.65 days to issue a dust permit.
- Conducted 3,511 construction inspections from January 1, 2026, through June 30, 2026.
- As of June 30, 2026, there were 1,776 active permits with a total of 26,445.92 acres of permitted area.
- Held 27 dust classes with a total of 1,022 attendees.

➤ Compliance: Stationary Sources, Complaints and Enforcement

- Conducted 636 stationary source inspections from January 1, 2026, through June 30, 2026.
- Received and responded to 528 complaints from January 1, 2026, through June 30, 2026; responded to 527 (99.8%) complaints within 24-hrs.
- 67 Notices of Violation (NOVs) issued from January 1, 2026, through June 30, 2026:
 - 22 for construction/vacant land
 - 37 for stationary sources
 - 7 for asbestos
 - 1 for vacant land
- Recommended \$516,300.00 in penalties from January 1, 2026, through June 30, 2026. Hearing Officer levied \$360,235.00.
 - \$118,460.00 has not yet been adjudicated.
 - Out of the 67 NOVs issued between January 1, 2026, through June 30, 2026, 17 resulted from complaints which is approximately 25%.

➤ Small Business Assistance Program

- SBAP staff responded to 1,068 requests for assistance (529 for permitting assistance and 539 for compliance assistance) from January 2026 through June 2026.

- The SBAP staff work primarily from the office. We are meeting with customers with walk-in questions, visiting their businesses, and continue offering assistance via phone calls, emails, and virtual meetings.

- DES amended existing Air Quality Regulations (AQRs) for various reasons including incorporating EPA feedback and 2015 O₃ Serious Attainment SIP requirements, updating language for clarity, and correcting citations.
- Section 12.0, “Applicability and General Requirements for Permitting Stationary Sources,” amendment effective 4/1/2026
 - Section 12.2, “Permit Requirements for Major Sources in Attainment Areas (Prevention of Significant Deterioration),” amendment effective 6/3/2026
 - Section 12.3, “Permit Requirements for Major Sources in Nonattainment Areas,” amendment effective 6/3/2026
 - Section 12.4, “Authority to Construct Application and Permit Requirements for Part 70 Sources,” amendment effective 6/3/2026
 - Section 12.5, “Part 70 Operating Permit Requirements.” amendment effective 6/3/2026
- DES promulgated new AQRs to satisfy requirements for the 2015 O₃ Serious Attainment plan.
- Section 131, “VOC Emissions Control for Emulsified Asphalt,” adoption effective 4/1/2026 - a contingency measure that has not been triggered
 - Section 108, “VOC Emissions Control for Film, Foil, Paper, Fabric, and Vinyl Coating Operations,” adoption effective 6/17/2026
 - Section 122, “Reasonably Available Control Technology for Major Sources in HA 212,” was adopted and replaced the repealed Section 121, “Reasonably Available Control Technology Determinations for Specific Major Stationary Sources in the 2015 8-Hour Ozone NAAQS Moderate Nonattainment Area HA 212,” effective 6/17/2026
- DES submitted general SIP revision packets for AQR amendments and adoptions to NDEP that will be forwarded to EPA for incorporation into the Nevada SIP.
- Amendments to Sections 12.1 and 102 were submitted to NDEP on 5/14/2026 and are pending submittal by NDEP to the EPA
 - Amendments to Sections 12.0 and adoption of Section 131 were submitted to NDEP on 6/10/2026 and are pending submittal by NDEP to the EPA.

➤ Desert Conservation Program

- MSHCP Permit Amendment
 - On July 21, 2026, the MSHCP Amendment goes before the Board of County Commissioners for authorization to submit the application package to the U.S. Fish and Wildlife Service. The MSHCP Amendment will allow the County to continue to provide non-federal development activities a streamlined permitting process under the Endangered Species Act for an additional term of 50 years.
 - A nomination package has been submitted to the Bureau of Land Management to establish nine new areas of critical environmental concern (ACECs), which will form the basis of the mitigation strategy under the MSHCP Amendment.
- In-Lieu Fee Program
 - DCP is coordinating with Clark County Regional Flood Control District to establish an in-lieu fee mitigation program that will provide project proponents an option to purchase credits to meet mitigation requirements for permits issued under Section 404 of the Clean Water Act. The U.S. Army Corps of Engineers has approved the Enabling Instrument for the establishment of this program.
- Annual Project Progress Symposium
 - On August 31, 2026, the DCP will host its Annual Project Progress Symposium at the Silverado Ranch Community Center. Agency partners, stakeholders, and interested parties are invited to attend and receive an annual update on work toward implementing the Clark County MSHCP.

➤ Office of Sustainability

- Finalized the interagency report *Regional Priorities and Considerations: Assembly Bill 96 Heat Mitigation Master Plan Integration*. It has been circulated across Southern Nevada as a resource to support regional alignment across AB 96-required Master Plan Updates.
- Continues to host and lead the Southern Nevada Clean Cities Coalition (SNCC), a Department of Energy-designated coalition that promotes and educates the Clark County community on Sustainable Transportation. It has developed core initiatives including student-led idling campaigns and fleet manager roundtables. Currently, there are 274 SNCC members and 2026 events have been attended by approximately 420 people.
- Continues to lead the Regional Climate Collaborative (RCC), a collaborative under interlocal agreement that works together to safeguard long-term social, environmental, and economic resilience of the region. In addition to quarterly collaborative meetings, the RCC's 3 working groups are responsible for providing impactful programming and resources for the region. Examples of impact include

the development of a tree planting initiative tracker and interim legislative session sustainability issues tracking.

- Continues the Community Canopy program which will enter its 4th year in 2027. In partnership with the Arbor Day Foundation, the program provides approximately 4,500 trees annually to Clark County residents with priority given to heat-vulnerable residents. As of July 2026, the program has cumulatively provided 9,625 trees with 58% of all trees distributed to individuals in urban heat island-vulnerable zip codes.
- Provides extreme heat resiliency support across Southern Nevada. The office is providing of 1,300 Regional Transportation Commission (RTC) of Southern Nevada bus passes to promote access to cooling stations during extreme heat. Passes are provided to cooling station staff and HELP of Southern Nevada. Efforts also include providing education to cooling station staff, developing flyers and fact sheets, distributing energy efficiency guides and cooling towels, and the establishment of a Southern Nevada Heat Resources Map.
- Continues the climate ambassador program through County Fiscal Year 2027, employing up to 12 part time outreach staff. As of July 2026, The Office of Sustainability's education and outreach efforts have reached over 6,000 residents across urban and rural Southern Nevada.

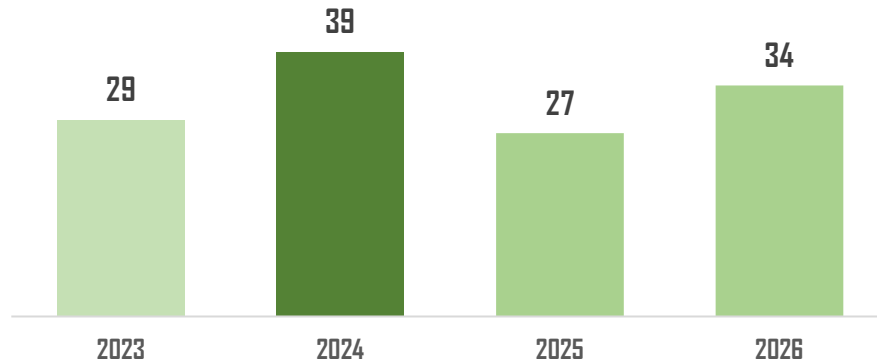
- **Media relations**

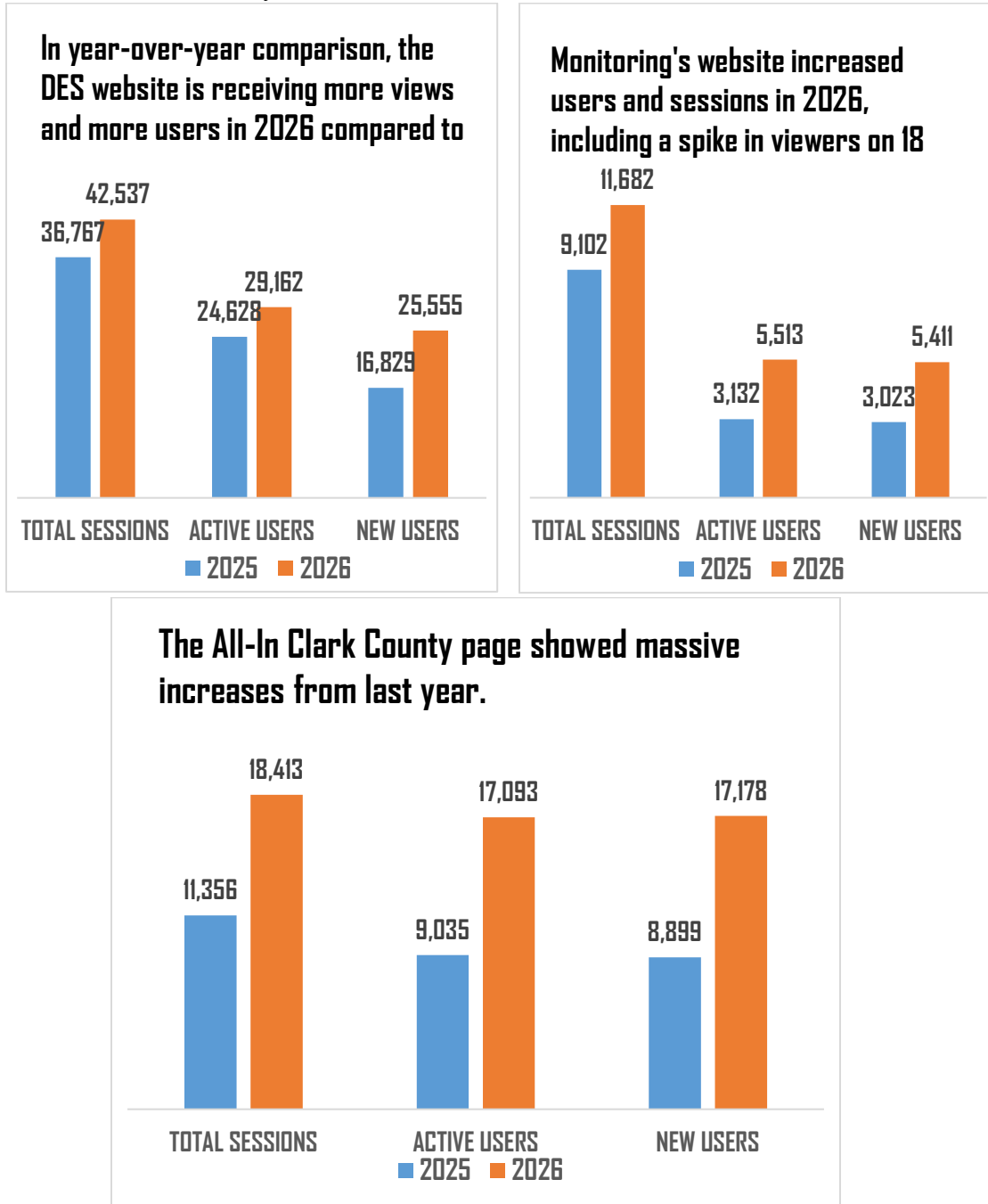

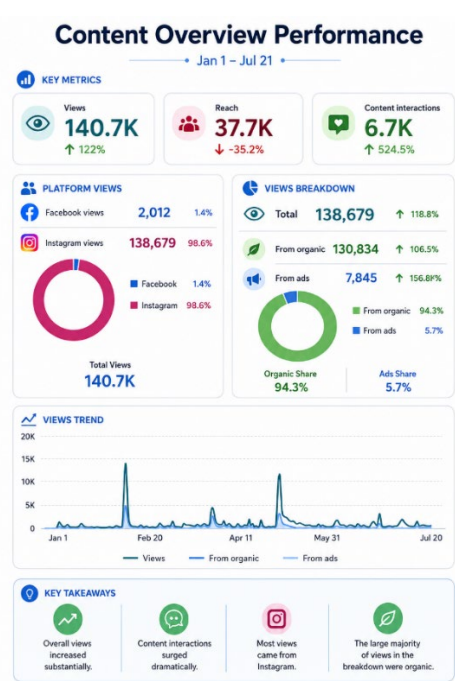
