### **Proposed Changes to Clark County Code**

### **RE: Title 13, Chapter 13.04**

The Clark County Board of Commissioners is proposing rule changes to Clark County Code to adopt the 2024 International Fire Code (IFC). The 2024 IFC will replace the current 2018 version of the fire code. In addition to the updated code year, new permit requirements are being added for fire pumps and kitchen fire suppression systems. Changes to the fire fee structure are also proposed. Along with the adoption of the IFC, multiple National Fire Protection Association (NFPA) standards are also being amended. NFPA 13, 13D, 13R, 14, 20, 22, 24, 30, 55, 72, 160, 109, 1123, 1126, 1225, and 2001 are amended in this proposal. Please note that there are some provisions in Title 13 that appear to be new but are in fact being reorganized to accommodate additions and changes included in this adoption. The proposed adoptions address the following key areas:

**Section 13.04.020:** Amend to remove references to outdated code year(s) and update to reflect adoption of the 2024 International Fire Code (IFC). Added subsection (B) to address conflicts.

**Section 13.04.030:** Amend section title and modified verbiage.

Prior to the adoption of the proposed rule, the Clark County Board of County Commissioners is required by NRS 237.080 to make a concerted effort to determine whether the proposed rule will impose a direct and significant economic burden upon a business or directly restrict the formation, operation or expansion of a business. Due to this, trade associations, owners and officers of businesses which are likely to be affected by this proposed rule, and any other interested persons are required to be notified and provided an opportunity to submit comments, data, or arguments to the County regarding whether the proposed rule will:

- a) Impose a direct and significant economic burden upon a business; or
- b) Directly restrict the formation, operation or expansion of a business.

Comments must be submitted no later than **5:00 p.m. on September 18, 2025**, as follows:
