Public Notice:

Proposed Addition to Clark County Code

RE: Title 13, Chapter 13.08

The Clark County board of Commissioners is proposing rule changes to Clark County Code to adopt the International Wildland-Urban Interface Code (IWUIC). There will be new requirements for construction and maintenance of property located within the areas considered wildland or wildland-urban interface according to this code. The proposed rule will modify Clark County Code Title 13, Chapters 13.08.010, 13.08.020, 13.08.030, 13.08.050, 13.08.060, 13.08.0801 and 13.08.085. The proposed adoptions address the following key areas:

Section 13.08.010: Added chapter title as Wildland-Urban Interface Code of Clark County (IWUIC).

Section 13.08.020: Added to adopt subsection (A) International Wildland-Urban Interface Code 2024 Edition. Added to adopt subsection (B) Conflict.

Section 13.08.030: Added establishment of Bureau of Fire Prevention.

Section 13.08.050: Added authority to issue administrative or misdemeanor citations.

Section 13.08.060: Added to reflect amendments to IWUIC.

Section 13.08.070: Added to reflect amendments to Chapter 1 of IWUIC.

Section 13.08.080: Added to reflect amendments to Chapter 3 of IWUIC.

Section 13.08.085: Added to reflect amendments to Chapter 4 of IWUIC.

Prior to the adoption of the proposed rule, the Clark County Board of County Commissioners is required by NRS 237.080 to make a concerted effort to determine whether the proposed rule will impose a direct and significant economic burden upon a business or directly restrict the formation, operation or expansion of a business. Due to this, trade associations, owners and officers of businesses which are likely to be affected by this proposed rule, and any other interested persons are required to be notified and provided an opportunity to submit comments, data, or arguments to the County regarding whether the proposed rule will:

- a) Impose a direct and significant economic burden upon a business; or
- b) Directly restrict the formation, operation or expansion of a business.
