- V. Receive the Director's Report on the Activities of the Department of Juvenile Justice Services (DJJS
 - a. Budget/Personnel Update
 - **i.** The JPO Academy is in mid-swing with 7 officers from DJJS and 1 from the State. Graduation is set for November 18.
 - **ii.** Budget wise, we continue to focus on expanding our professional services. This includes assessing our group homes to ensure quality services are provided and staff have had trauma informed trainings, even if that means DJJS provides the actual trainings.
 - **b.** Legislature No update.
 - **c. Juvenile Detention Reform** Mr. Martin is researching the costs involved in building a new detention center. The current facility was built in the 1960s and is in need of costly renovations. Mr. Martin thanked Steve Morris for keeping us moving forward on this project.
 - **d. Juvenile Justice Programming** Our clinical team is researching trauma informed methodology training for our staff.
 - **e.** The Harbor Update (formerly known as the Assessment Center) The Harbor had its soft opening October 17. The first two weeks, we served more than 20 families that were referred from community partners or walk in families needing services. Mr. Martin again invited anyone from this board for a tour of the facility.
 - f. Strategic Plans

i. Mr. Martin met with his management team to discuss future 1,3 and 5 year goals for their divisions. They will continue to move forward on those.

- **c. Gender Specific Programming** The board discussed how they could show support for DJJS and Mr. Martin's goals of a Medicaid carve out and finding creative quality programming for girls and specialized populations and ultimately providing more placement options other than detention. They will plan to attend the upcoming Policy and Fiscal meeting, Board of County Commissioner meetings, and contacting Medicaid Administration directly if needed.
- **d.** Training and Quality Assurance Mr. Martin would love to provide trauma informed trainings to future in home providers to ensure appropriate care is given to youth.
- e. Expanding Resources for juvenile justice clients exiting the system
 - i. The board discussed having only 1 provider in Southern Nevada for youth with substance abuse problems and how to improve that. Mr. Martin has been working on solutions and shared a few with the board on how to find tangible, quality in home services.
 - **ii.** Dave Doyle brought up the lack of resources available to youth exiting the JJ system compared to youth exiting child protective services and how to ensure all youth have the same opportunities for success.
 - **iii.** Mr. Martin shared his goals of breaking ground on a new residential center in 2017 and renovating the existing one for a girls' home with appropriate services for a 2018 project.
