I attended the Route 91 Harvest Festival in 2017 and was stuck in the front right side of the stage when the shooting started. My fiancé and I had to lay down on the grass for all eight rounds and had to dive and hide under the stage until 10:36pm. This was the scariest night of my life and I will never be able to unsee the things I witnessed that night. For three years I've seen eight Theripist and two Psychiatrists and let me tell you there is no amount of therapy that can help. I still have severe PTSD and a lot of emotional problems that are caused from October 1, 2017. The only thing that has helped me is talking with other Survivors and the families of the "58" families that lost their life THAT NIGHT! I am very saddened that after 3 years someone has the nerve to announce the official number is going to be changed to 60 people during a sunrise service while we are HONORING are 58 Angels. So many others have taken their lives or passed away that we're not counted or included and had time to say goodbye to their families. Please leave this alone and stop changing the narrative to whatever you want! It will ALWAYS be "58"

My Route 91 Family and I will not back down and it will FOREVER be "58"

#### From: Martin Gallagher

My wife, Carolann, and I are Route 91 survivors. I watched the Sunrise Remembrance Ceremony and heard Sheriff Lombardo say that from today on the official references will be to 60 and no longer to 58.

Everyone associated with Route 91 has been so connected to the number 58 since that night, with everything from tattoos using the number 58 to the names of fundraising groups and social media groups to even pausing in remembrance whenever we come across the number 58. Survivors, their

families and friends, as well as victims' families and friends have all placed special emphasis on the number 58 since that night, with many interpreting seeing it in their daily lives as signs from Above.

I'd like to suggest using "58+" as the official reference instead of 60. That would allow people to simply add a "+" to tattoos, names, organizations, etc. and to continue the healing process associated with being mindful of the number 58.

More than 2 survivors have died since the initial 58 victims died, some due to suicide and accidents. Many continue to suffer from PTSD, depression, and physical injuries so it's likely that the number will continue to go up as time passes. It doesn't make sense to keep changing the number since nobody knows what the exact number even is at this point.

#### From: Stacy & Greg Meadows

The night of October 1, 2017 our lives, along with thousands of others changed forever. Our precious daughter, Kelsey Meadows (28), is one of the 58 victims killed during the mass shooting at Rt. 91 festival. 58 families got that devastating phone call. 58 families never got to hug their loved one. 58 families never got to say "I love you" one last time. 58 families had to meet with officials to identify their loved one. 58 families had to plan funerals. It was, and still is a devastating and life altering event.

We know there were hundreds injured and thousands struggling to learn how to live again. Our hearts go out to the families of those that have passed since that horrific night.

Over the last 3 years the number 58 has turned into a symbol. A symbol that we are not alone on our journey of grief. A symbol of hope for some, a symbol that our angel is sending us a sign. We look for the number 58 on receipts, on the clock, on the temperature gauge and anywhere else we can find the number 58. It is a symbol that unites the 58 families and the rest of the Rt. 91 family.

It is our sincere hope that the number "58" stays intact as a symbol of all that was lost on October 1, 2017.
