

LEGACY TRAIL PARKING LOT AT CHARLESTON BLVD/SKY VISTA DR

RED ROCK LEGACY TRAIL CYCLIST SCULPTURE DISTRICT F

Scope: To create a public art piece is a celebration of cycling while honors lost cyclists to be placed at the Legacy Trail.

Funding Estimate: \$175,000

Stakeholders: District F, Public Works, BLM/FHWA/NDOT, Cycle Community Leaders, Long Range Planning.

Location: Trailhead parking lot on the Summerlin side adjacent to West Career & Tech Academy.

Background: The Legacy Trail was originally conceived after a prominent cyclist (Don Albietz) was killed by an 18-wheeler while riding along SR159, and as you know, there have unfortunately been too many cycling deaths over the years. There is a temporary placement of a Ghost Bike at Charleston along the Beltway Trail in memory of the five riders who were killed a few years ago near Boulder City. While that Ghost Bike could be moved to the trailhead parking lot, I think it would be a lot more meaningful if Clark County commissioned a public art piece to honor lost cyclists to be placed at the Legacy Trail parking lot/trailhead.

TEMPORARY PLAY ART: LEMONDE

Scope: To bring high quality interactive public art to our community.

Funding Estimate: \$100,000

Stakeholders: P&R, RPM, Public Works, Economic Development

Background: LeMonde Studio is a movement toward greener entertainment combining art and sensible technology.
